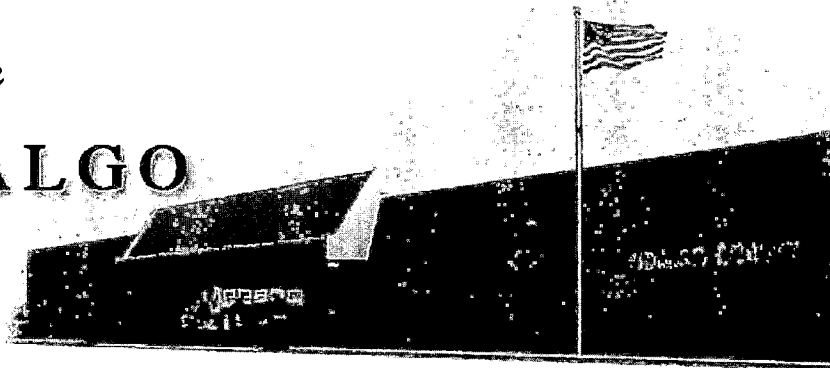



Commissioners Court:

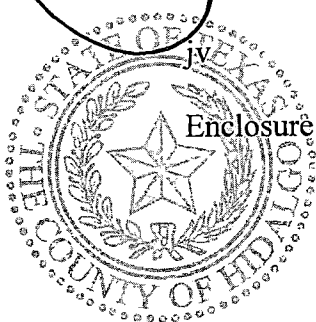
