**FIRST AMENDMENT TO UNIFORM RENTAL AGREEMENT  
BETWEEN THE COUNTY OF HIDALGO  
AND CINTAS**

This **First (1<sup>st</sup>) Amendment** to the Uniform Rental Agreement dated **April 18, 2023**, by and between the **County of Hidalgo, Texas** (“County”) and **Cintas** (“Company”) is entered into and between the parties effective this 14<sup>th</sup> day of May, 2024.

**WHEREAS**, on April 18, 2023 Company and County entered into a Uniform Rental Agreement for the purpose of Uniform Rental for the Hidalgo County Forensic Center (the “Contract”) through the Omnia Cooperative (R-BB-19002);

**WHEREAS**, Section 7 titled Adding Employees of the Supplier General Service Terms Section allows for the addition of employees and merchandise;

**WHEREAS**, the Hidalgo County Forensic Center is in need of additional uniforms for new employees;

**WHEREAS**, the parties desire to amend the contract hereinafter provided to include such additional employees.

**NOW THEREFORE**, for and in consideration of the terms and provisions of this contract and for good and valuable consideration the receipt and sufficiency of which are hereby acknowledged, Cintas and the County of Hidalgo hereby agree to the following amendment to the Uniform Rental Agreement:

1. Section “Pricing and Service Summary” is hereby modified to include under “Number of Pieces” the new amounts as follows:
  - Scrub Top – 50
  - Scrub Pant – 50
  - Size Premium – 20
  - Prep Advantage – 100
  - Uniform Advantage - 100
2. Except as modified herein, all terms and conditions of the Master Agreement, as amended, remain in full all other provisions in the original master agreement will remain in effect.
