**SECOND AMENDMENT TO REQUIREMENTS AGREEMENT
C-23-0134-08-22**

This **SECOND (2ND) AMENDMENT** to the service contract for “**Mats, Dust Mops & Shop Rags & Towels**” for **Hidalgo County** in connection to original contract **C-23-0134-08-22**, dated August 29, 2023, by and between **HIDALGO COUNTY, TEXAS** (“County”) and **Unifirst Corporation** (“Company”) is entered into between the parties effective this **23th** day of **July 2024**.

WHEREAS, Company and County entered into a Contract dated **August 29, 2023**, in which Company agreed to provide certain services for the purpose of “**Mats, Dust Mops & Shop Rags & Towels**” for **Hidalgo County** (the “Contract”);

WHEREAS, Section m, titled “Entire Agreement” allows for C-23-0134-08-22 to be modified or amended “only by an agreement in writing executed by County and Company, and not otherwise”;

WHEREAS, on or about June 20, 2024, Company and County entered into a First Amendment to the Requirements Agreement to reflect additional service locations.

WHEREAS, the parties now desire to further amend the Contract to include additional buildings in “Attachment I – Locations Sites”;

NOW, THEREFORE, for and in consideration of the terms and provisions set forth herein, for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, County and Company hereby agree to the following amendment to the Contract:

1. The Locations Sites list portion of Attachment I of the initial contract is replaced by the updated Locations Sites list included herein for all purposes as Attachment A.

Except as modified herein, all terms and conditions of the Contract, as amended, remain in full force and effect and Company and County ratify and confirm the terms, and provisions of the Contract as amended.
