**FIRST AMENDMENT TO
SERVICE AGREEMENT
(C-22-0195-08-09)**

This **AMENDMENT** to Requirements Agreement (“Agreement”) for “**Registered Pharmacist Services**” is made this **23rd** day of **July, 2024**, by and between the **COUNTY OF HIDALGO, TEXAS** hereinafter referred to as (“County”) and **Max Castro, R.Ph.,MBA**, hereinafter referred to as the (“Vendor”).

WHEREAS, on August 9, 2022, County entered into a Service Agreement, with Max Castro, R.Ph.,MBA, (“Vendor”), in which Vendor agreed to provide a service to Hidalgo County, for Registered Pharmacist Services, as described in the contract;

WHEREAS, Section 19, titled “Entire Agreement” allows for C-22-0195-08-09 to be modified or amended only by agreement in writing executed by both parties, and not otherwise.

WHEREAS, parties desire to amend the agreement to provide clarification of Appendix A of the agreement by including facility locations and to reflect a pricing increase.

NOW THEREFORE, for and in consideration of the terms and provisions set forth herein, for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, County and Vendor hereby agree that said Agreement is amended as follows:

1. “Appendix A: Scope of Services” of the Agreement shall be substituted and replaced with the newly revised “Appendix A: Scope of Services”, attached herein as Attachment A, which includes all County health clinic pharmacy locations.
2. The Fee Schedule page in “Appendix A: Scope of Services” of the Agreement shall be amended as follows:

The Monthly Flat Rate is amended to **\$8,100.00**.

All other information in “Appendix A: Scope of Services” remains the same.

Except as modified herein, all terms and conditions of the Agreement, as amended by this Amendment, remain in full force and effect and Vendor and County ratify and confirm the terms and provisions of the Agreement as amended.
