**1st AMENDMENT TO SERVICE CONTRACT
C-23-0172-06-30**

This **AMENDMENT** to the service contract for “**Bio-Hazardous & Medical Waste Disposal Services and Supplies**” for Hidalgo County in connection to original contract **C-23-0172-06-30**, dated **June 30, 2023**, by and between **HIDALGO COUNTY, TEXAS** (“County”) and **Stericycle, Inc.** (“Company”) is entered into between the parties effective **August 06, 2024**.

WHEREAS, Company and County entered into a Contract dated **June 30, 2023**, in which Company agreed to provide certain services for the purpose of “**Bio-Hazardous & Medical Waste Disposal Services and Supplies**” for Hidalgo County (the “Contract”);

WHEREAS, Section j, titled “Entire Agreement” allows for **C-23-0172-06-30** to be modified or amended “only by an agreement in writing executed by County and Company, and not otherwise”;

WHEREAS, the parties desire to amend the Contract to include an additional building in “Exhibit B - Company’s Response” of the initial contract;

WHEREAS, parties wish to compile all service locations to date, including the additional building added by this Amendment, into one attachment, which is attached as Attachment A.

NOW, THEREFORE, for and in consideration of the terms and provisions set forth herein, for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, County and Company hereby agree to the following amendment to the Contract:

1. The site list portion of Exhibit B of the initial contract is replaced by the updated site list included herein for all purposes as Attachment A.

Except as modified herein, all terms and conditions of the Contract, as amended, remain in full force and effect and Company and County ratify and confirm the terms, and provisions of the Contract as amended.
