**RESOLUTION AUTHORIZING EXECUTION OF AN ADVANCE FUNDING AGREEMENT (AFA) WITH THE TEXAS DEPARTMENT OF TRANSPORTATION WITH AUTHORITY FOR THE COUNTY JUDGE TO SIGN THE AGREEMENT AND ANY AND ALL PERTINENT DOCUMENTATION FOR THE HIGHWAY SAFETY IMPROVEMENT PROGRAM OFF-SYSTEM PROJECT FOR THE ADDITION OF LEFT AND RIGHT TURN LANES AT THE INTERSECTIONS OF CANTON ROAD & CESAR CHAVEZ ROAD, RAMSEYER ROAD & DOOLITTLE ROAD, TEX MEX ROAD & 83<sup>RD</sup> STREET, AND MILE 22 ½ N ROAD & CARMEN AVILA ROAD.**

WHEREAS, on August 16, 2023, via Minute Order 116522, the Texas Transportation Commission authorized Hidalgo County – Left & Right Turn Lanes project (the "Project") to receive Highway Safety Improvement Program funds for project construction and Texas Department of Transportation (TxDOT) oversight; and

WHEREAS, the County of Hidalgo commits to provide the match. The local match is comprised of cash and transportation development credits; and

WHEREAS, the County of Hidalgo is responsible for all nonreimbursable costs and 100% of overruns, if any; and

WHEREAS, the Governing Body of the County of Hidalgo desires to reaffirm its support of the Project, approve and authorize the execution of an Advance Funding Agreement (AFA) and any and all pertinent documentation with TxDOT for the Project.

NOW, THEREFORE, BE IT RESOLVED BY THE County of Hidalgo THAT the County Judge is authorized to enter into an AFA with TxDOT for this Project and sign said agreement and any all pertinent documentation with TxDOT.
