**AMENDMENT NO. 1  
TO MEMORANDUM OF AGREEMENT BETWEEN  
METHODIST HEALTH CARE MINISTRIES OF SOUTH TEXAS, INC.  
AND HIDALGO COUNTY**

This FIRST AMENDMENT to the Memorandum of Agreement is made on this 3<sup>rd</sup> day of September, 2024, by and between the COUNTY OF HIDALGO, TEXAS (hereinafter referred to as “County”), and Methodist Health Care Ministries of South Texas, Inc. (hereinafter referred to as “MHMSTX”), collectively referred to as “Parties”.

**WITNESSETH:**

**WHEREAS**, on October 19, 2021, MHMSTX and County of Hidalgo, entered into a Memorandum of Agreement;

**WHEREAS**, the purpose of this Agreement is to establish a cooperative agreement to facilitate and provide education and resource development to help improve the self-sufficiency, health and well-being of the residents of the COUNTY, including use of available County.

**WHEREAS**, Section 13 “TERM OF AGREEMENT” of the Memorandum of Agreement allows C-21-0842-10-19 upon mutual agreement of Parties, to amend the Agreement to extend the term for up to three (3) additional years.

**WHEREAS**, the Parties desire to amend the Agreement to exercise its option for renewal of the agreement.

**NOW THEREFORE**, for and in consideration of the terms and provisions of this Amendment to the Memorandum of Agreement and for good and valuable consideration the receipt and sufficiency of which are hereby acknowledged, MHMSTX and County hereby mutually agree to amend the Agreement as follows:

1. The Agreement shall be extended for a period of three (3) additional years, to run from October 19, 2024 to October 18, 2027, as permitted under section 13 of the Agreement.

Except as modified herein, all terms and condition of the Agreement, as amended, remain in full force and effect, and the Parties ratify and confirm the terms, and provisions of the Agreement as amended.
