The Hidalgo County Health and Human Services, in conjunction with the Hidalgo Urban County Program, seeks to procure the purchase of BD BACTEC MGIT 960 and 320, BD EpiCenter NUC Computer, BD EpiCenter Basic Software, Service, and Consumables from Becton, Dickinson Diagnostic Systems.

Becton, Dickinson Diagnostic Systems in Sparks, MD is the Sole Source Supplier, sole distributor and sole manufacturer in Sparks, MD for the MGIT960 and 320 System and consumables (as listed in proposal). For Customers in the United States who want to purchase the MGIT 960 and/or 320 System and consumables, the only source is direct purchase from Becton Dickinson.

The BD BACTEC™ MGIT™ 320 Instrument is the only fully automated system for the incubation and rapid detection of mycobacteria in clinical specimens other than blood. Currently the Becton Dickinson (BD) BACTEC MGIT 320 automated system, a FDA approved test system, specially designed for rapid growth and propagation of Mycobacteria. The MGIT products are manufactured and distributed by BD. These reagents are components of the FDA approved test system and must be used in part of the testing process for mycobacteria cultivation and to determine the drug resistance status of Mycobacterium tuberculosis isolates. No other reagents may be substituted to use with the BACTEC MGIT 320 instrument.
