This **AMENDMENT** to the service contract for “**OpenGov Software Services Agreement**” for **Hidalgo County** in connection to original contract **C-24-0142-05-14**, dated **May 14, 2024**, by and between **HIDALGO COUNTY, TEXAS** (“**County**”) and **Vertosoft LLC** (“**Company**”) is entered into between the parties effective this **3rd** day of **September 2024**.

WHEREAS, **Company** and **County** entered into a **Contract** dated **May 14, 2024**, in which **Company** agreed to provide certain services for the purpose of “**OpenGov Software Services Agreement**” for **Hidalgo County** (the “**Contract**”);

WHEREAS, the parties now desire to further amend the **Contract** to include additional services;

NOW, THEREFORE, for and in consideration of the terms and provisions set forth herein, for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, **County** and **Company** hereby agree to the following amendment to the **Contract**:
