THIS **SUPPLEMENTAL AGREEMENT** is made pursuant to the terms and conditions of the project specific Professional Services Agreement made by and between **HIDALGO COUNTY**, acting herein by and through the **Commissioner’s Court**, hereinafter called the “**Owner**”, and B2Z Engineering, LLC, hereinafter called the “**Engineer**”.

WITNESSETH

WHEREAS, the **Owner** and the **Engineer** executed the **Agreement No. C-21-0944-02-08** on the day of February 8, 2021 concerning Recreational Trails Connectivity Project within Hidalgo County Precinct #2;

WHEREAS, on the 17th day of September 2024, **Owner** authorized a Project Specific Work Authorization for construction management services and construction material testing services for the construction of the Pct. 2 Recreational Trails Connectivity Project- McAllen Segment 2 (hereinafter referred to as the “**Project**”); and

WHEREAS, it has become necessary to supplement “Exhibit B – Contract Rates” of the agreement to reflect additional contract rates for Construction Materials Testing Services.

NOW, THEREFORE, in consideration of the mutual covenants provided below, the **Owner** and the **Engineer** agree that said Agreement is amended as follows:

- I. Parties agree to supplement Exhibit B of the **Agreement**, “Contract Rates,” to reflect additional contract rates for Construction Materials Testing Services attached hereto as Attachment A and hereby incorporated by reference for all purposes as part of the agreement (C-21-0944-02-08).

- II. **All other provisions are unchanged and remain in full force and effect.**

IN WITNESS WHEREOF, the Engineer and the Owner have caused this Supplemental Agreement to the Agreement for Professional Services to be executed and effective as of the date indicated below.
