Good Afternoon Mr. Rodriguez,
Thank you for the additional information. Since the current engagement with LEO Tech ends 9-20-24 and their recent letter indicates new continued funding for another year, then we recommend submitting a new agenda item similar to the 9/20/22 language to address extension of services.

We also recommend advising the LEOTech of the Willacy location which is under the purview of the HCSO.

If the vendor acknowledges this location is covered, then we recommend the first sentence in the Background of the Agenda be modified to indicate:

"The Versus will work with current communications systems in place at all Hidalgo County Jail locations under control of the HCSO."

The Background will also need to be changed to reflect the new term.

After approval, the Sheriff may send out the new letter to Correct Solutions Group.
