

Substance Use Among Pregnant and Parenting Populations

women and their families. Edith first joined HHSC in 2019 as a program specialist, followed by a promotion to special projects coordinator and more recently to program manager.

In addition to her manager responsibilities, Edith is a member of the National Association of State Alcohol and Drug Agency Directors (NASADAD) and serves as their Women's Services Network (WSN) coordinator for Texas. She also serves on the NASADAD WSN executive committee as the WSN Region VI Representative and executive committee secretary.

Edith was born and raised in Texas. She received her bachelor's degree in psychology from the University of North Texas; and her master's degree in counseling from Texas State University.
