Dear Ms. Sanchez,

I am in receipt of your offer letter dated 11/10/23, in which the Texas Department of Transportation and Hidalgo County are offering me \$10,353.00 for my land and improvements. After a review of the appraisal report and your offer letter, we have decided to reject the offer.

The reasoning and basis for our rejection is that because of the corner clip right of way taking, my land remainder will not be dimensional and will lose value on the real estate market. Furthermore, the proposed right of way line will be closer to my residence and will be a safety hazard to the livability and use of the church. It will be necessary to construct a protection and privacy fence at the corner of Cesar Chavez Road, and Sioux Rd. Since the appraisal is almost 1 year old, the prices of land, material and labor, have also gone up substantially.

In view of the above information, we are asking that a counter- offer in the amount of \$12,553.00 be considered. If this amount is considered and approved, I am willing to finalize the acquisition of Parcel 72.


Analysis and Conclusion:

Our approval/ disapproval recommendation is based on the items checked above and has been evaluated as follows: (attach additional sheets as necessary)

Parcel 72 is a 0.015 of an acre (644 sq. ft.) parcel of land situated in Hidalgo County, Texas and also being a part or portion of a certain 1.00 acre tract out of Lot 4, Block 39, ALAMO LAND AND SUGAR COMPANY'S SUBDIVISION. On November 10, 2023, Acquisition Provider, L & G Engineering, made an offer of \$10,353.00 Rio Grande Valley Apostolic Church (Pastor: Jose Rodriguez), via certified mail. On September 25, 2024, Property owner submitted a counter offer for \$12,553.00. In their counter offer they state that they feel prices of land, material, and labor have gone up substancially. They feel the road is going to be closer to the church and the playground area, and they would like to build a fence for safety privacy and protection. Based on the information provided within the the counter offer and discussion by the acquisition team it is recommended that the Administrative Settlement be approved. The difference between the approved value versus the property owner's counter offer is \$2,200.00. We believe that the proposed counter offer is not within a reasonable range, thus resulting in a cost saving issue to the County.

This administrative settlement of \$ 12,553.00 is / is not recommended for approval as being reasonable, justified, prudent and in the public interest.

In acquiring property for the highway system of Texas, the Texas Department of Transportation (the "Department") and Hidalgo County (the "County") follow a definite procedure for appraising the land needed and for handling personal negotiations with each owner. As has been or will be explained by the County's negotiator, Novelia Sanchez, a portion of your property located on Cesar Chavez Road, as described in the enclosed property description, is to be acquired for the construction or improvement of the above-referenced highway project.

We believe at this stage of the purchase process it is mutually beneficial to confirm that, based on an appraisal, the County is authorized to offer you **\$10,353.00** for the Property, which includes **\$8,927.00** for the Property to be purchased and **\$1,426.00** for damages to your remaining property. This amount is the total amount of just compensation for all interests in the portion of the property to be acquired, as determined in accordance with State law, less oil, gas, and sulfur, subject to clear title being conveyed to the County. In accordance with State law, it is the policy of the Department/County to negotiate with the fee owner(s) of the Property with the understanding that you will, in turn, negotiate with any lessee or other party who may own any interest in the land or improvements, with the exception of public utility easements, which will be handled separately by the Department/County.

This offer to purchase includes the contributory values of the improvement(s) listed below, which are considered to be part of the real Property. Since the improvement(s) must be removed, it is the policy of the Department/County to permit owners who convey voluntarily to the State to thereafter retain the improvement(s), if they wish to do so. The retention values shown below are estimated amounts the improvement(s) would bring if sold on public bids. If you wish to retain title to any of the following improvement(s) and remove it (them) from the right of way, the above offer must be reduced by the appropriate retention amount(s). This option to retain the improvement(s) does NOT apply should it become necessary for the County to acquire the real Property by eminent domain.

If you are not willing to accept this offer, you may submit a written request for administrative settlement/counteroffer, setting forth a counteroffer amount and the basis for such amount, provided such settlement request is received in writing within 30 days from the date of this letter. Please note that your opportunity to submit an administrative settlement shall be forfeited if such a settlement request is not received by the Department/County within the 30-day time deadline. In the event the condition of the Property changes for any reason, the County shall have the right to withdraw or modify this offer.

After the date of payment of the purchase price, or the date of deposit in court of funds to satisfy the award of compensation as determined through eminent domain proceedings to acquire the Property, you will be reimbursed for any fair and reasonable incidental expenses necessarily incurred in transferring title to the Property for use by the Texas Department of Transportation/Hidalgo County. Expenses eligible for reimbursement may include (1) recording fees, transfer taxes, and similar expenses incidental to conveying the real Property to the County, and (2) penalty costs for prepayment of any preexisting recorded mortgage entered into in good faith encumbering the real Property. Voluntary unnecessary expenses or expenses incurred in clearing questionable title will not be eligible for reimbursement. Eligible incidental expenses will be reimbursed upon submission of a claim supported by receipted bills or other evidence of actual expenses incurred. You may file a written request for review if you believe that the Department/County failed to properly determine the eligibility for, or the amount of, incidental expenses to be reimbursed. There is no standard form on which to request a review of a claim; however, the claim must be filed with this office within six months after you are notified of the Department's/County's determination on any claim for reimbursement.

You may be entitled to additional payments and services under the State's Relocation Assistance Program. It is emphasized, however, that any benefits that you may be entitled under this program will be handled entirely separate from and in addition to this transaction. You will receive a brochure entitled "*Relocation Assistance*", which will inform you of eligibility requirements, payments, and services that are available.

You have the right to discuss with others any offer or agreement regarding the Department's/County's acquisition of the subject Property, or you may (but are not required to) keep the offer or agreement confidential from others, subject to the provisions of Chapter 552, Government Code (the Public Records Act) as it may apply.

Please see the enclosed copy of the proposed instrument that will convey the Property and any improvement owned by you on the Property to the Department. Additionally, please see the enclosed copy of the Texas Landowner Bill of Rights.

Also enclosed is a copy of the Texas Department of Transportation brochure entitled "*Right of Way Purchase*", which we trust will give you a better understanding of the procedures followed by the Department in purchasing property. We respectfully request the opportunity to meet with you or to otherwise discuss and answer any questions you may have regarding the details of the type of facility to be built or concerning the County's offer or proposed purchase transaction. Parcel 72 appears to be a parcel taking of 0.015 of an acre (644) sf. parcel of land being a part or portion of a certain 1.00 acre tract out of Lot 4, Block 39, Alamo Land and Sugar Company's Subdivision, Hidalgo County, Texas

This parcel is located at the Southwest corner of Cesar Chavez Road and Sioux Road within the City of San Juan, Texas. The whole property containing a church is owned by Rio Grande Valley Apostolic Church. The highest and best use is for Commercial Use.

Three (3) recent comparable sales are utilized to value the whole property at \$5.50 per sf. The part taken is properly valued as a pro-rata part of the whole property unit value. There are no market damages to the remainder land.

A breakdown of the total compensation is as follows: Land owned by Rio Grande Valley Apostolic Church to be \$3,542.00, improvements owned by Rio Grande Valley Apostolic Church are \$5,385.00 and the cost to cure damages is \$1,426.00 totaling \$10,353.00.

The appraiser has considered access damages in accordance with Section 21.042(d) of the Texas Property Code, as amended by SB18 of the Texas 82nd Regular Legislative Session. The result of the findings is that there is no denial of direct access nor material impairment of direct access on or off the remaining property that affects the market value of the remaining property. Therefore, there are no access damages to the remainder property.

The report prepared by the appraiser Leonel Garza III is an Appraisal Report presented on TxDOT form ROW A-5 and appears to comply with USPAP and the Texas Department of Transportation's Appraisal and Review Manual. The appraisers' opinion and conclusions appear to be well supported by information contained within this appraisal report. It is recommended that the total value of \$10,353.00 be approved for negotiations and acquisition.
