**1st AMENDMENT FOR CONSULTING SERVICES
C-22-0580-11-29**

This First Amendment is made as of the 17th day of December 2024 by and between the County of Hidalgo, Texas (the “County”) and Syntax Ware (“Company”), collectively referred to as (the “Parties”).

WHEREAS, Company and County entered into a Consulting Agreement dated **November 29, 2022**, in which Company agreed to provide certain services for the purpose of “**Consulting Services Related to all technical support and defect resolution for the Invoice Tracker and Sanitation Permitting System with additional technical support and defect resolution for TAAP system, payroll reporting and salary upload process** (hereinafter “Service”) for Hidalgo County (the “Contract”);

WHEREAS, Section j, titled “Entire Agreement” allows for **C-22-0580-11-29** to be modified or amended “only by an agreement in writing executed by County and Company, and not otherwise”;

WHEREAS, it has become necessary and the parties desire to amend the Contract to add requirements and specifications to “Exhibit A – Scope of Services” of the initial contract for the remainder of its term;

WHEREAS, the parties also desire to amend the Contract to clarify and include the rates for the additional scope of work, as referenced in “Exhibit B – Cost of Services” of the initial contract for the remainder of its term;

WHEREAS, parties wish to update the requirements and specifications, which is attached herein as “Appendix A” and include the resulting clarification of fees, which is attached as “Appendix B” herein;

NOW, THEREFORE, for and in consideration of the terms and provisions set forth herein, for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, County and Company hereby agree to the following amendment to the Contract:

1. Exhibit A – Scope of Services of the initial contract is modified to include the following two additional scopes of services which are both incorporated therein for all purposes:
 - a. The Scope of Services related to *Payroll Automation – Leave Accrual Blocking* located in the attached Appendix A; and
 - b. The Scope of Services related to *Payroll Automation – Election Workers Payroll Input* located in the attached Appendix B.

2. Exhibit B – Cost of Services of the initial contract is modified to include the following two additional costs of services which are both incorporated therein for all purposes:
 - a. The Cost of Services related to *Payroll Automation – Leave Accrual Blocking* located in the attached Appendix A; and
 - b. The Cost of Services related to *Payroll Automation – Election Workers Payroll Input* located in the attached Appendix B.

Except as modified herein, all terms and conditions of the Contract, as amended, remain in full force and effect and Company and County ratify and confirm the terms, and provisions of the Contract as amended.
