**1st AMENDMENT SERVICE AGREEMENT
C-22-0562-10-18**

This First Amendment is made as of the 28th day of January, 2025, by and between the County of Hidalgo, Texas (the “County”) and On-Demand Logistics Services, LLC (“Company”), collectively referred to as (the “Parties”).

WHEREAS, Company and County entered into a Services Agreement dated **October 18th, 2022**, in which Company agreed to provide certain services for the purpose of **“Moving/Relocation Services for Hidalgo County Courthouse”** (hereinafter “Service”) for Hidalgo County (the “Contract”);

WHEREAS, Section j, titled “Entire Agreement” allows for **C-22-0562-10-18** to be modified or amended “only by an agreement in writing executed by County and Company, and not otherwise”;

WHEREAS, the parties also desire to amend the Contract to clarify and include the updated total cost for the scope of work, as referenced in “Exhibit B – Bid Page” of the initial contract for the remainder of its term;

WHEREAS, parties wish to update the clarification of fees, which is attached as “Appendix B” herein;

NOW, THEREFORE, for and in consideration of the terms and provisions set forth herein, for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, County and Company hereby agree to the following amendment to the Contract:

1. Appendix B – Cost of Services of the initial contract is modified to reflect the updated total cost of the scope of work.

Except as modified herein, all terms and conditions of the Contract, as amended, remain in full force and effect and Company and County ratify and confirm the terms, and provisions of the Contract as amended.
