**FIRST AMENDMENT TO  
REQUIREMENTS AGREEMENT  
(C-22-0710-01-17)**

This **AMENDMENT** to Requirements Agreement (“Agreement”) for “**Punched & Drawn Biaxial Geogrid Reinforcement Material**” is made this **18<sup>th</sup>** day of **February 2025**, by and between the **COUNTY OF HIDALGO, TEXAS** hereinafter referred to as (“County”) and **Ferguson Enterprises, LLC dba Geo-Solutions**, hereinafter referred to as the (“Vendor”).

**WHEREAS**, on January 17, 2023, County entered into a Requirements Agreement, with GeoSolutions, Inc., (“Vendor”), in which Vendor agreed to provide a service to Hidalgo County, Purchase of Punched & Drawn Biaxial Geogrid Reinforcement Material, as described in the contract; and

**WHEREAS**, Section 13.j, titled “Entire Agreement” allows for C-22-0710-01-17 to be modified or amended “only by an agreement in writing executed by County and Company, and not otherwise”; and

**WHEREAS**, Vendor, has notified County of the recent change of name of Vendor from GeoSolutions, Inc. to Ferguson Enterprises, LLC dba Geo-Solutions and has provided a certificate of name change; and

**WHEREAS**, the parties desire to amend the Agreement to reflect such name change, as hereinafter provided.

**NOW THEREFORE**, for and in consideration of the terms and provisions set forth herein, for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, County and Vendor hereby agree that said Agreement is amended as follows:

1. **Ferguson Enterprises, LLC dba Geo-Solutions**, shall be the name of the company and the name **Ferguson Enterprises, LLC dba Geo-Solutions**, shall be substituted throughout the Contract in lieu of the name of GeoSolutions, Inc., wherever the name of GeoSolutions, Inc., appears in the Contract.

Except as modified herein, all terms and conditions of the Agreement, as amended by this Amendment, remain in full force and effect and Vendor and County ratify and confirm the terms and provisions of the Agreement as amended.
