My name is Oscar Villarreal and I am director at the Hidalgo County Facilities Management.

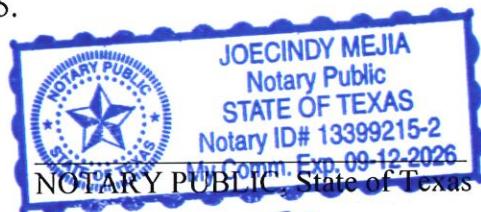
