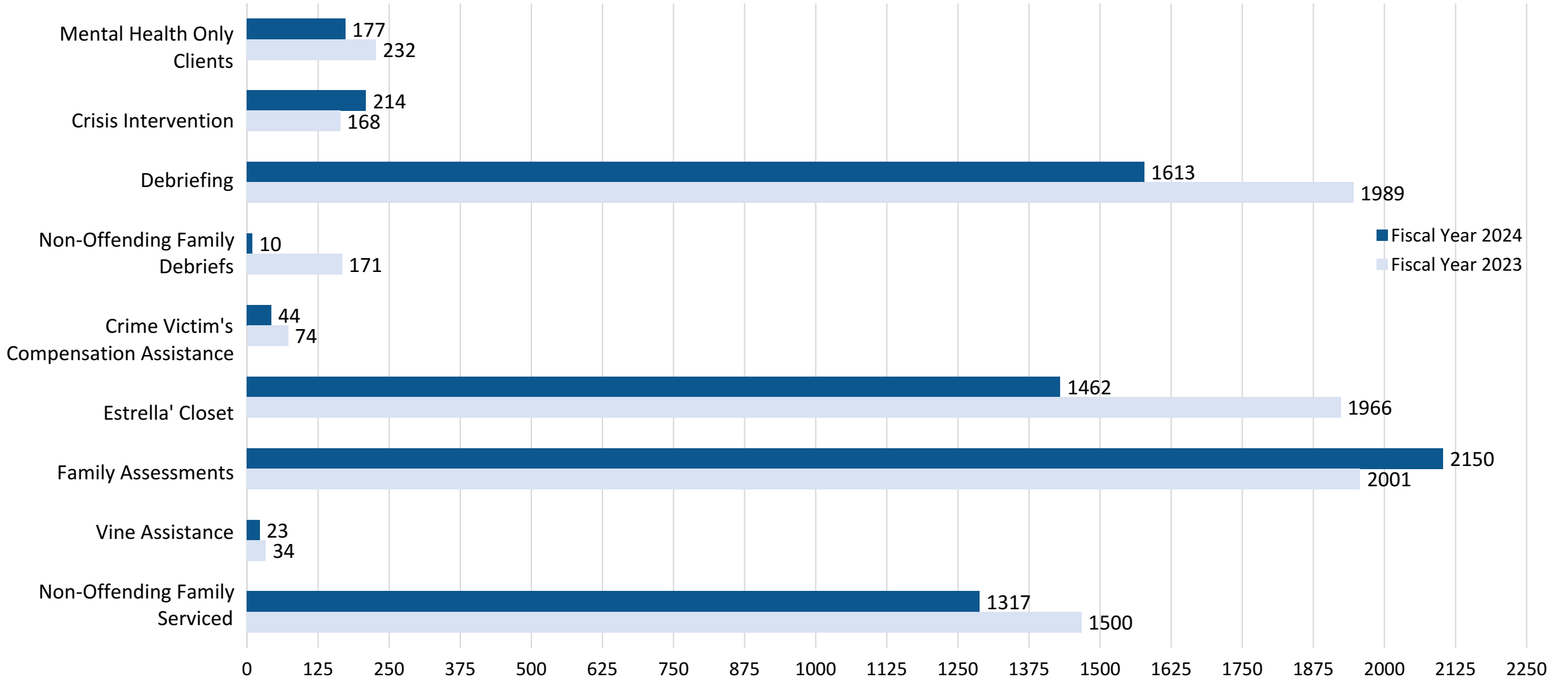

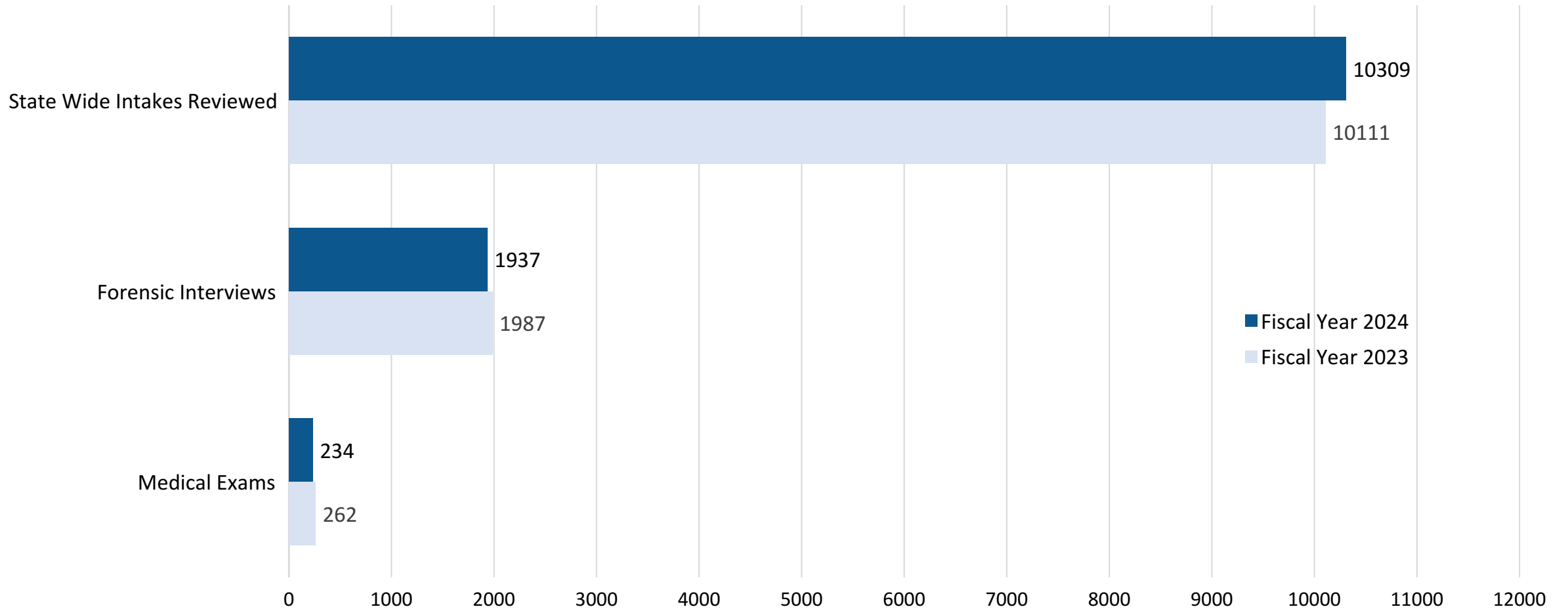

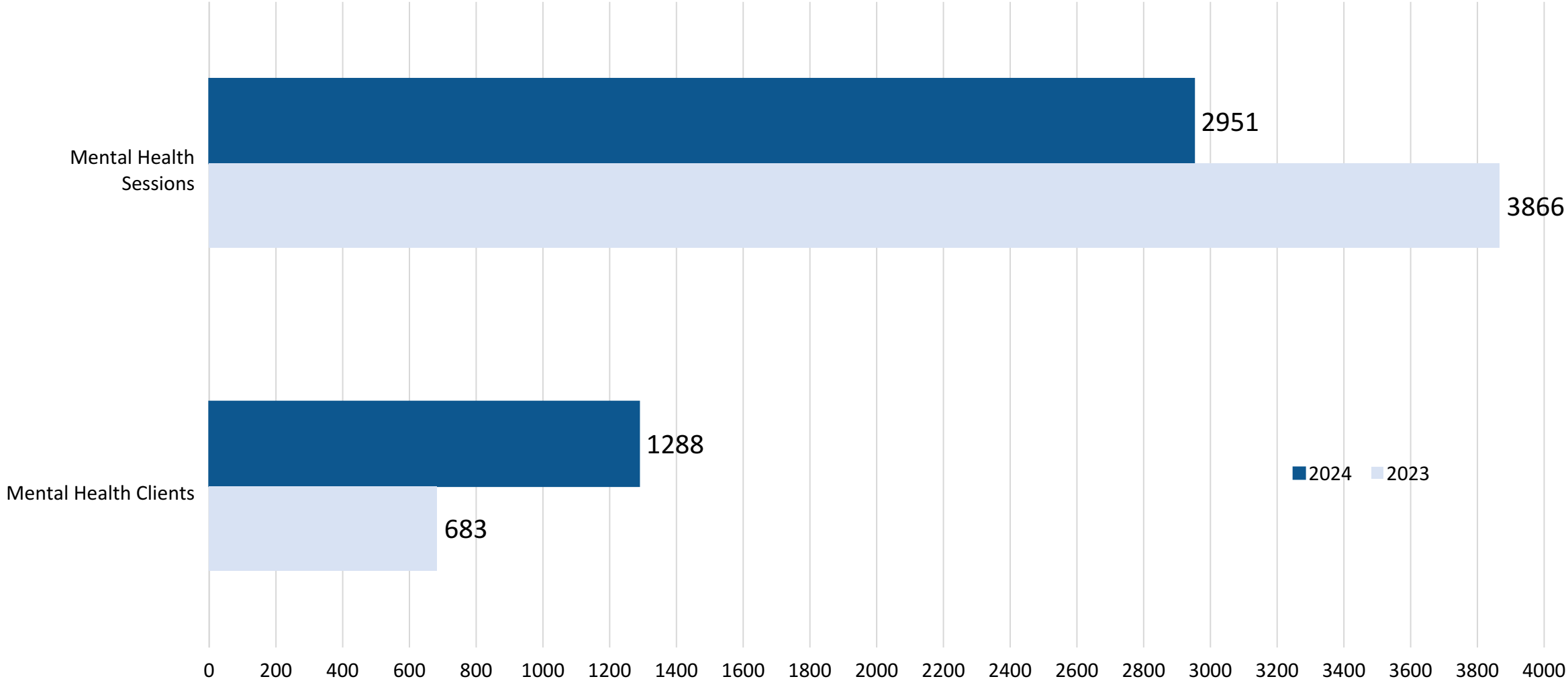

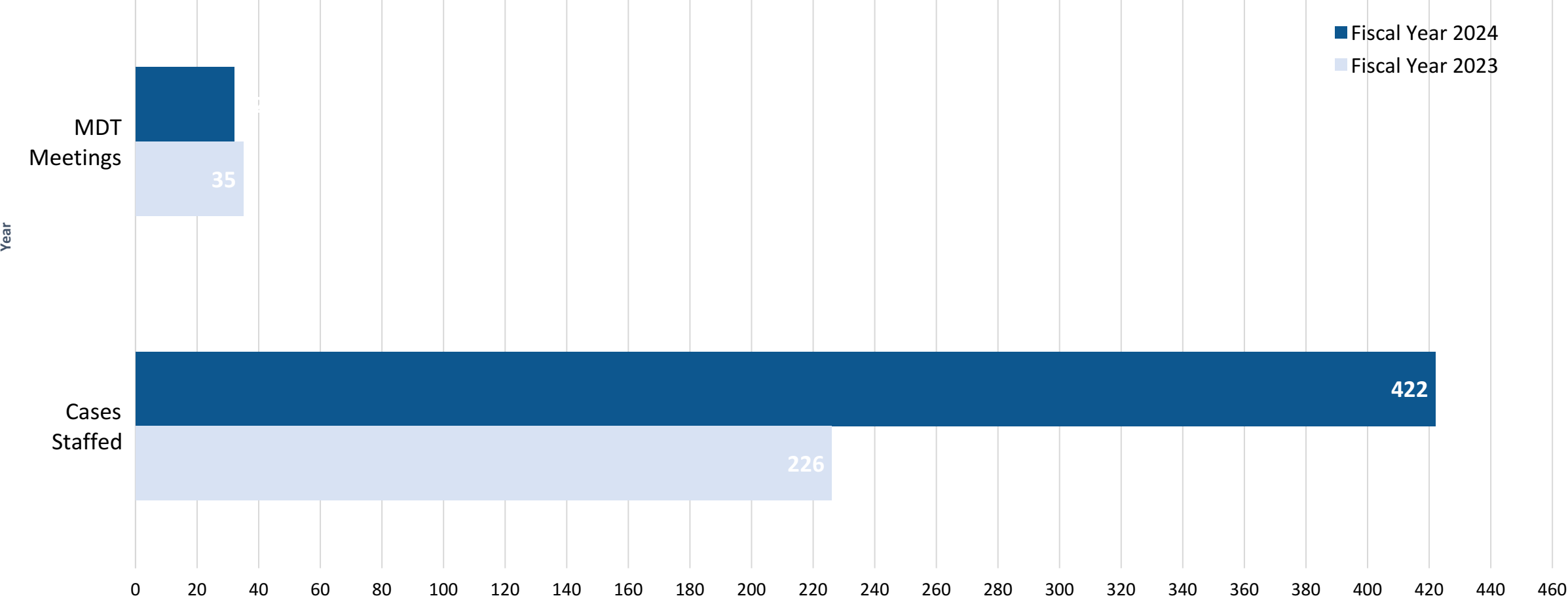

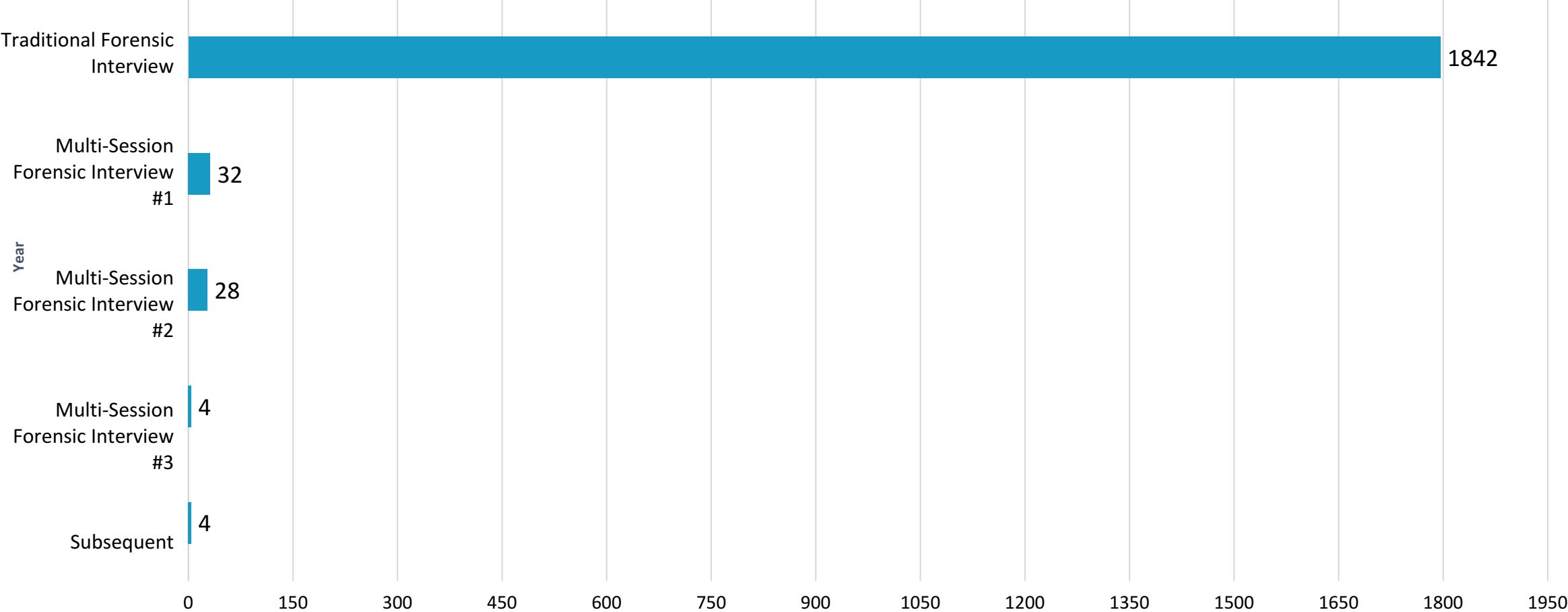

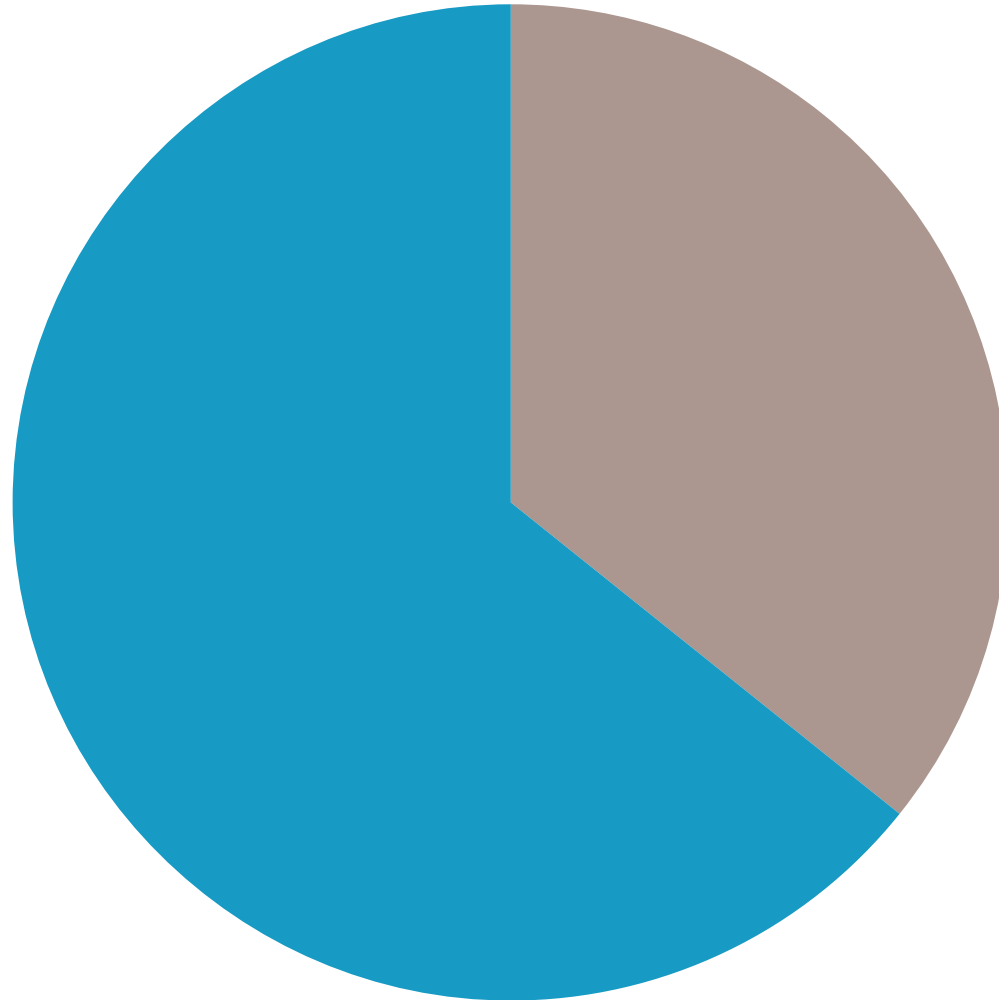

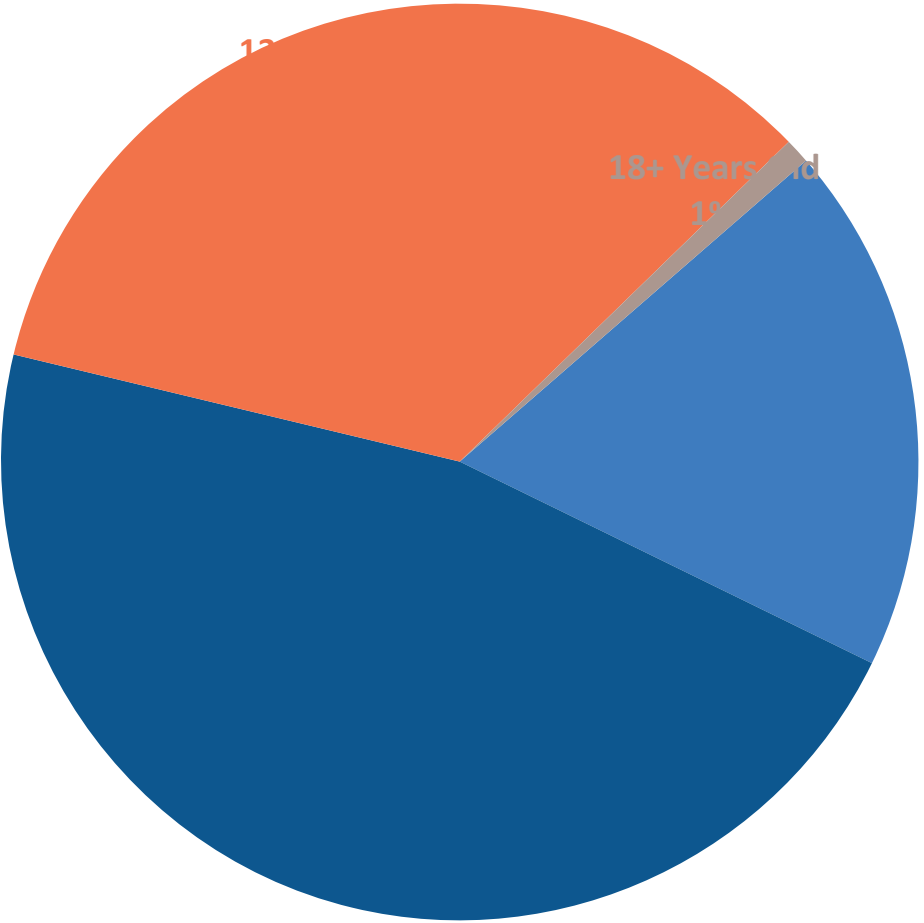

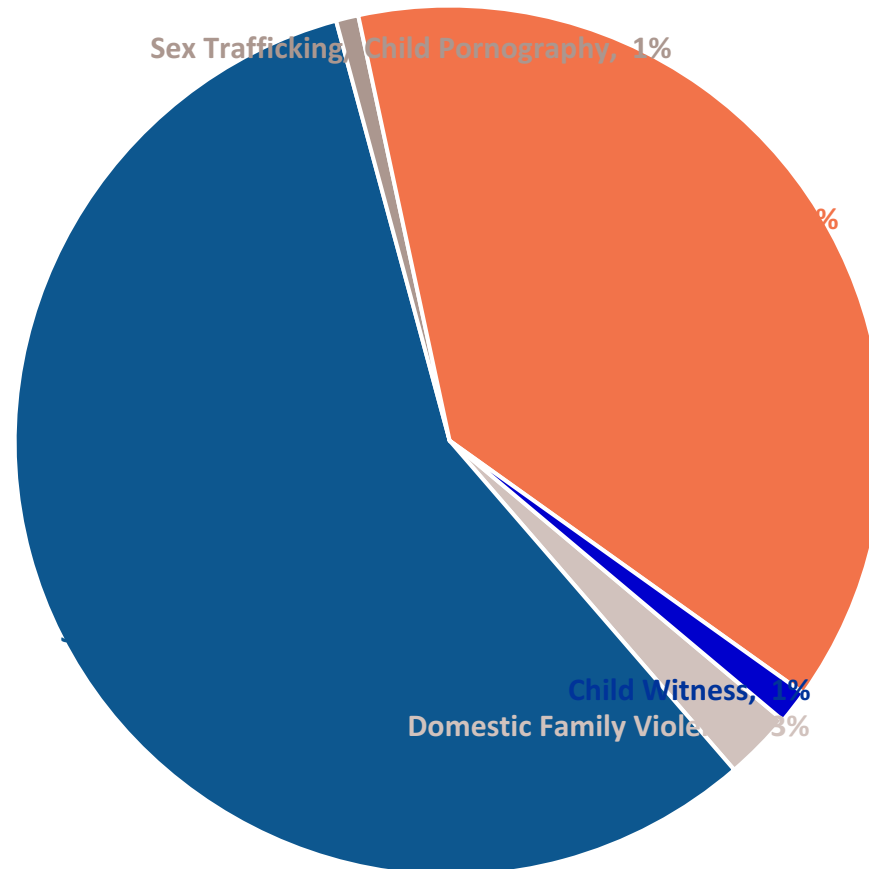
## TOTAL VICTIMS SERVED BY GENDER

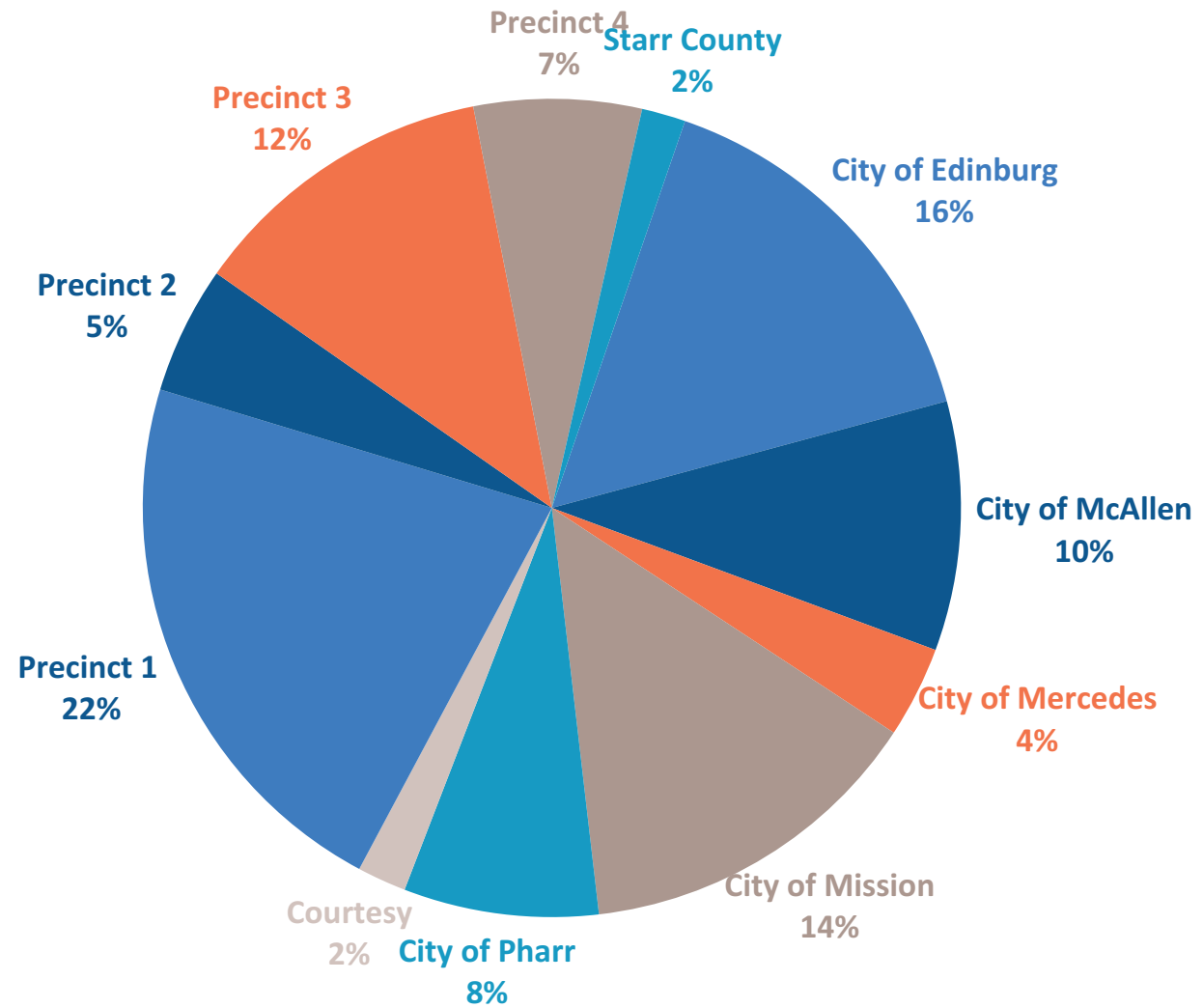

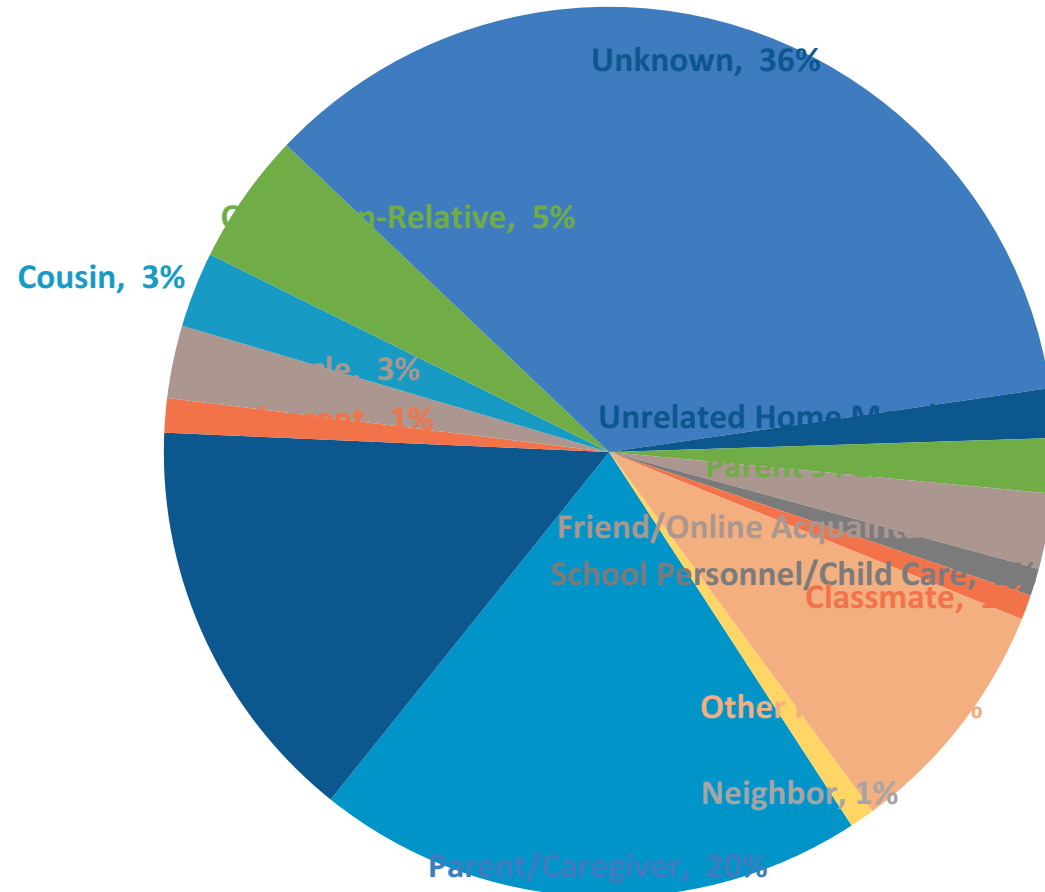

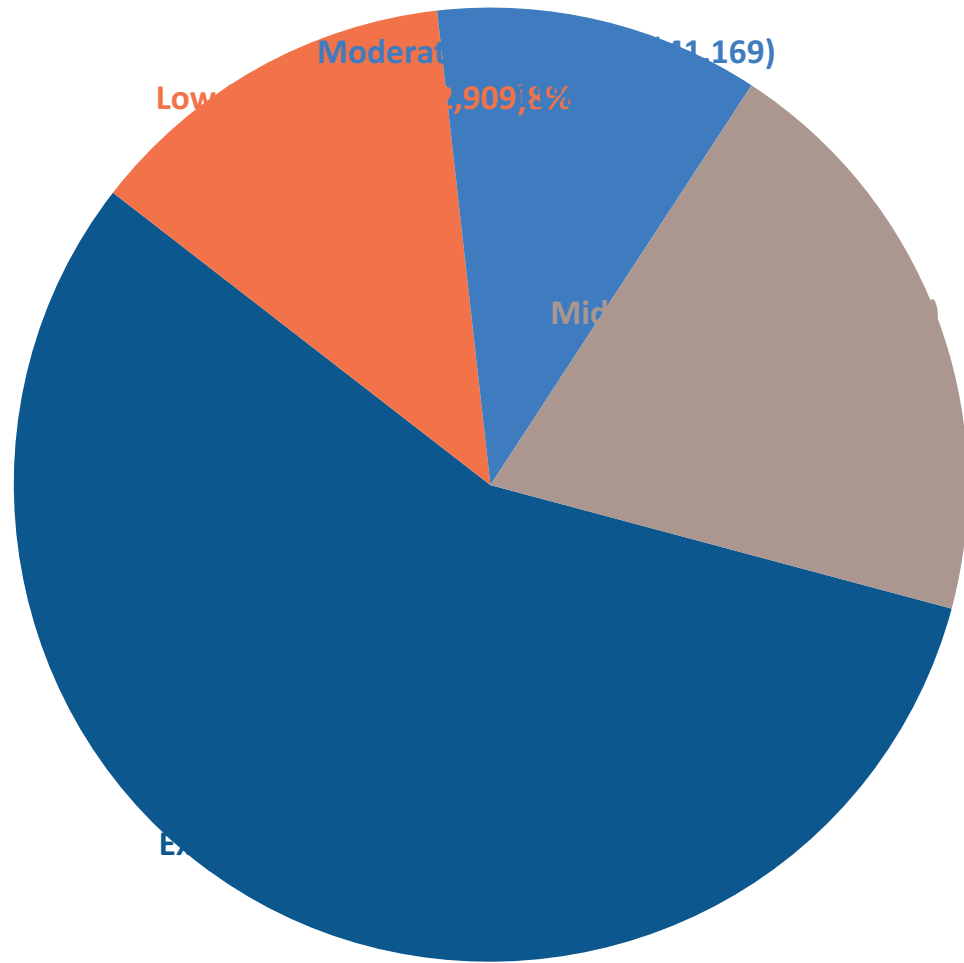

# ALLEGED PERPETRATOR'S RELATIONSHIP TO VICTIM

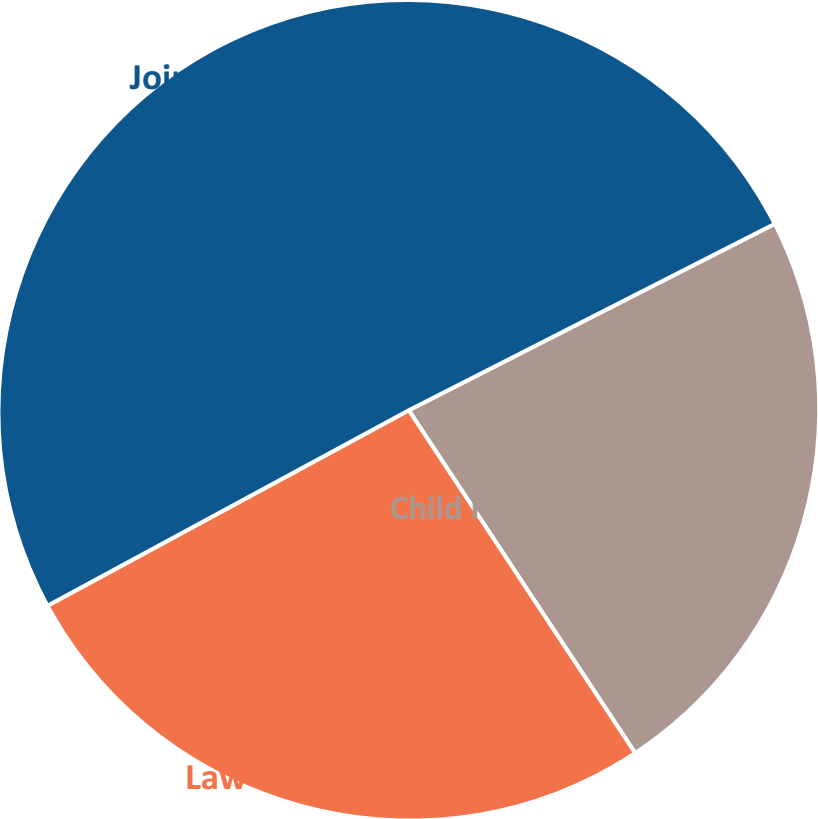


# VICTIMS SERVED BY INCOME LEVEL

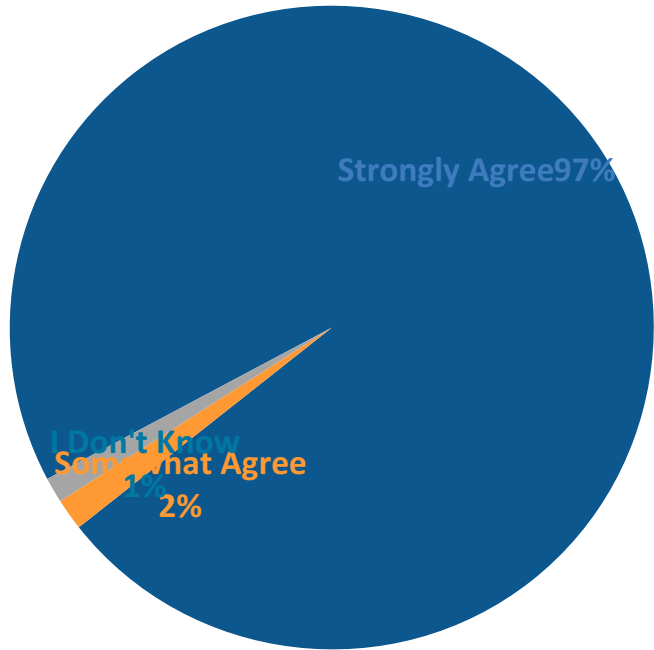

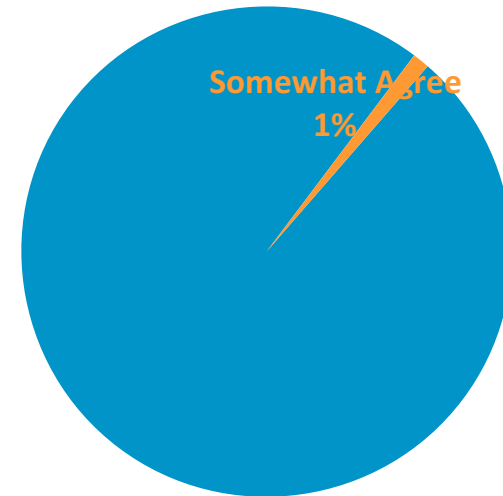
