**1st AMENDMENT TO SERVICE CONTRACT
C-21-0794-05-31**

This **AMENDMENT** to the service contract for “**Laboratory Services**” for Hidalgo County in connection to original contract **C-21-0794-05-31**, dated **May 31, 2022**, by and between **HIDALGO COUNTY, TEXAS** (“County”) and **Quest Diagnostics Clinical Laboratories, Inc.** (“Company”) is entered into between the parties effective **April 01, 2025**.

WHEREAS, Company and County entered into a Contract dated **May 31, 2022**, in which Company agreed to provide certain services for the purpose of “**Laboratory Services**” for Hidalgo County (the “Contract”);

WHEREAS, Section 19, titled “Entire Agreement” allows for **C-21-0794-05-31** to be modified or amended “only by an agreement in writing executed by County and Company, and not otherwise”;

WHEREAS, the parties desire to amend the Contract to include additional clinic sites in “**Appendix A – Requirements/Specifications**” of the initial contract;

WHEREAS, parties wish to compile all service locations to date, including the additional clinic sites added by this Amendment, into one attachment, which is attached as Attachment A.

NOW, THEREFORE, for and in consideration of the terms and provisions set forth herein, for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, County and Company hereby agree to the following amendment to the Contract:

1. The locations/clinics portion of Exhibit A of the initial contract is replaced by the updated Locations/Clinics list included herein for all purposes as Attachment A.

Except as modified herein, all terms and conditions of the Contract, as amended, remain in full force and effect and Company and County ratify and confirm the terms, and provisions of the Contract as amended.

Laboratory must also be in compliance with any mandated and/or applicable HIPPA and OSHA rules and regulations. Laboratory must have the necessary security measures to safeguard confidential information.
- 18) All prices and/or NB (no bid) must be indicated on the Bid page for each test (see Exhibit “B”- Bid page). No Alterations may be made to the Bid page, this may be a probable cause for disqualification.
