Request by HCRMA to update the status of all Projects in Hidalgo County


- L&G Engineering managers continue to update the status of project development activities to submit to RGVMPPO.

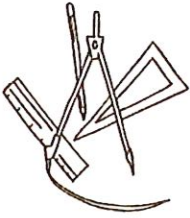
