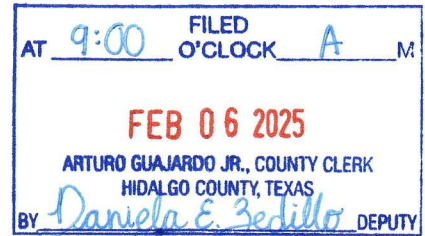

ORDER CALLING AN ELECTION TO CONFIRM THE CREATION OF HIDALGO COUNTY EMERGENCY SERVICES DISTRICT NO. 6 AND AUTHORIZE THE IMPOSITION OF A TAX RATE NOT TO EXCEED THE RATE ALLOWED BY SECTION 48-E, ARTICLE III, TEXAS CONSTITUTION

WHEREAS, the Hidalgo County Commissioners Court received PETITION FOR AN EMERGENCY SERVICES DISTRICT SEEKING TO CREATE HIDALGO COUNTY EMERGENCY SERVICES DISTRICT NO. 6;

WHEREAS, the Hidalgo County Commissioners Court conducted a public hearing on the Petition on February 4, 2025;

WHEREAS, the Hidalgo County Commissioners Court received, approved and granted the Petition as authorized by Texas Health and Safety Code §775.017; and

WHEREAS, the Hidalgo County Commissioners court made the requisite findings pursuant to Texas Health and Safety Code §775.017 that the creation of Hidalgo County Emergency Services District No. 6 would be feasible and would promote the public safety, welfare, health and convenience of persons residing in the proposed district.

IT IS THEREFORE ORDERED, ADJUDGED, AND DECREED BY THE COMMISSIONERS COURT OF HIDALGO COUNTY, TEXAS that:

1. An election be held to confirm the creation of HIDALGO COUNTY EMERGENCY SERVICES DISTRICT No. 6 and authorize the imposition of a tax authorized by Texas Health and Safety Code §775.018 not to exceed \$.10 per ONE HUNDRED DOLLAR (\$100.00) valuation;
2. The election shall be on the 3rd day of May 2025, which date is the next available uniform election date under Chapter 41, Texas Election Code;
3. The creation of the district at the election shall be by majority vote of all the voters who vote in the election;
4. The boundaries of the district are set forth in the attached Exhibit "A";
5. At the election, the below proposition shall be submitted to the qualified voters who reside in the proposed District;

CONFIRMATION OF THE CREATION OF HIDALGO COUNTY EMERGENCY SERVICES DISTRICT NO. 6 AND THE LEVY BY SAID DISTRICT OF A TAX NOT TO EXCEED TEN (10) CENTS PER ONE HUNDRED DOLLAR (\$100.00) VALUATION.

6. The ballot of the election shall conform to the requirements of the Texas Election Code, as amended, and shall have printed thereon the following;

AGAINGST	AND THE LEVY BY SAID DISTRICT OF A TAX NOT TO EXCEED TEN (10) CENTS PER ONE HUNDRED DOLLAR (\$100.00) VALUATION.

7. The Court shall enter any such Orders in furtherance of the Election called as it shall deem necessary and proper and as required under the Texas Election Code and Chapter 775 of the Texas Health and Safety Code, including, but not limited to the establishment of voting and election precincts, designation of Presiding and

alternate Presiding Judges, the polling place locations, the early voting ballot board and the posting and publication of the Election Notice.

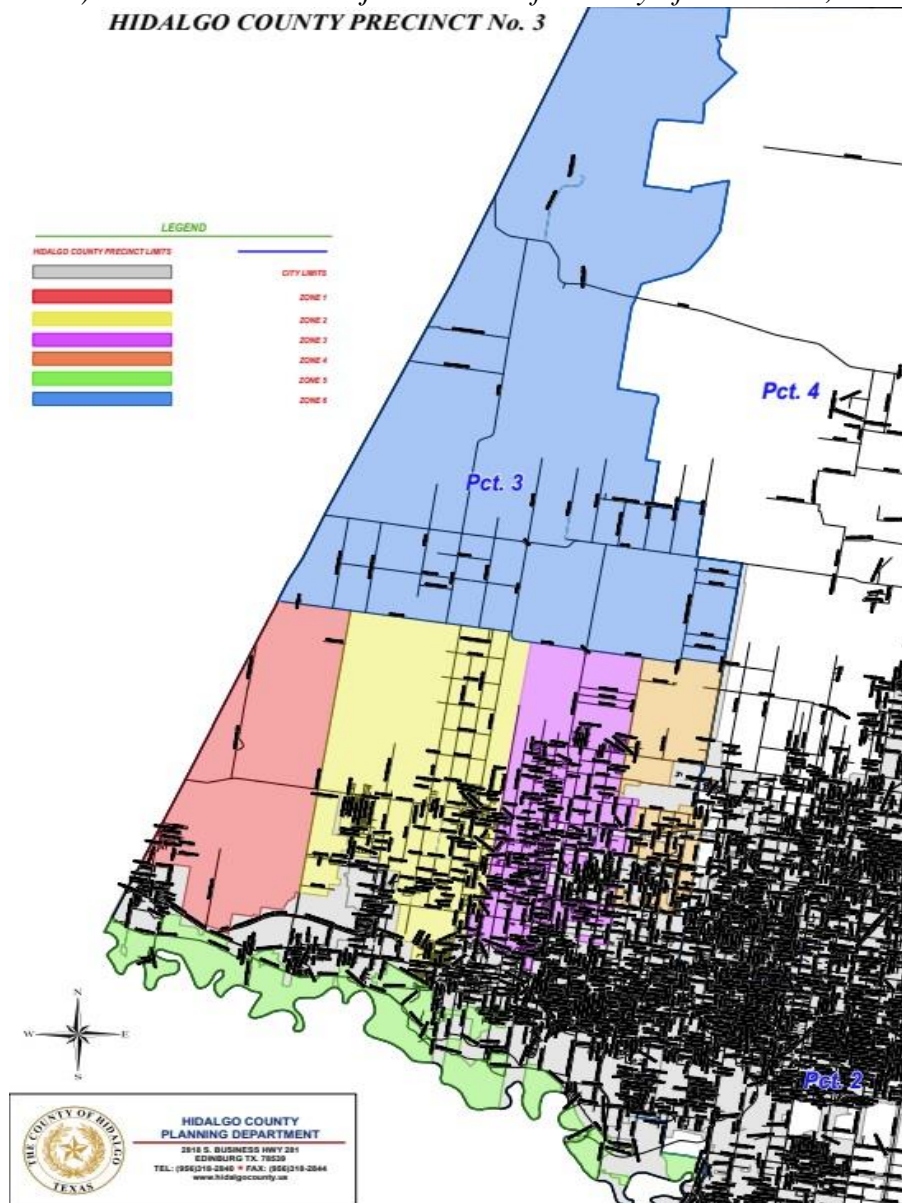
### Boundary Description of Hidalgo County Emergency Services District No. 6

The boundaries of Proposed Hidalgo County Emergency Services District No. 6, will include the totality of unincorporated Hidalgo County Precinct No. 3 not located within the extraterritorial jurisdiction of any municipality.

In addition to unincorporated Hidalgo County Precinct No. 3 not located within the extraterritorial jurisdiction of any municipality, Hidalgo County Emergency Services District No. 5, will include:

- 1.) The municipal boundaries of the City of Alton, TX,
- 2.) The extraterritorial jurisdiction of the City of Alton, TX,
- 3.) The extraterritorial jurisdiction of the City of La Joya, TX,
- 4.) The extraterritorial jurisdiction of the City of Mission, TX; and
- 5.) The extraterritorial jurisdiction of the City of Palmhurst, TX.

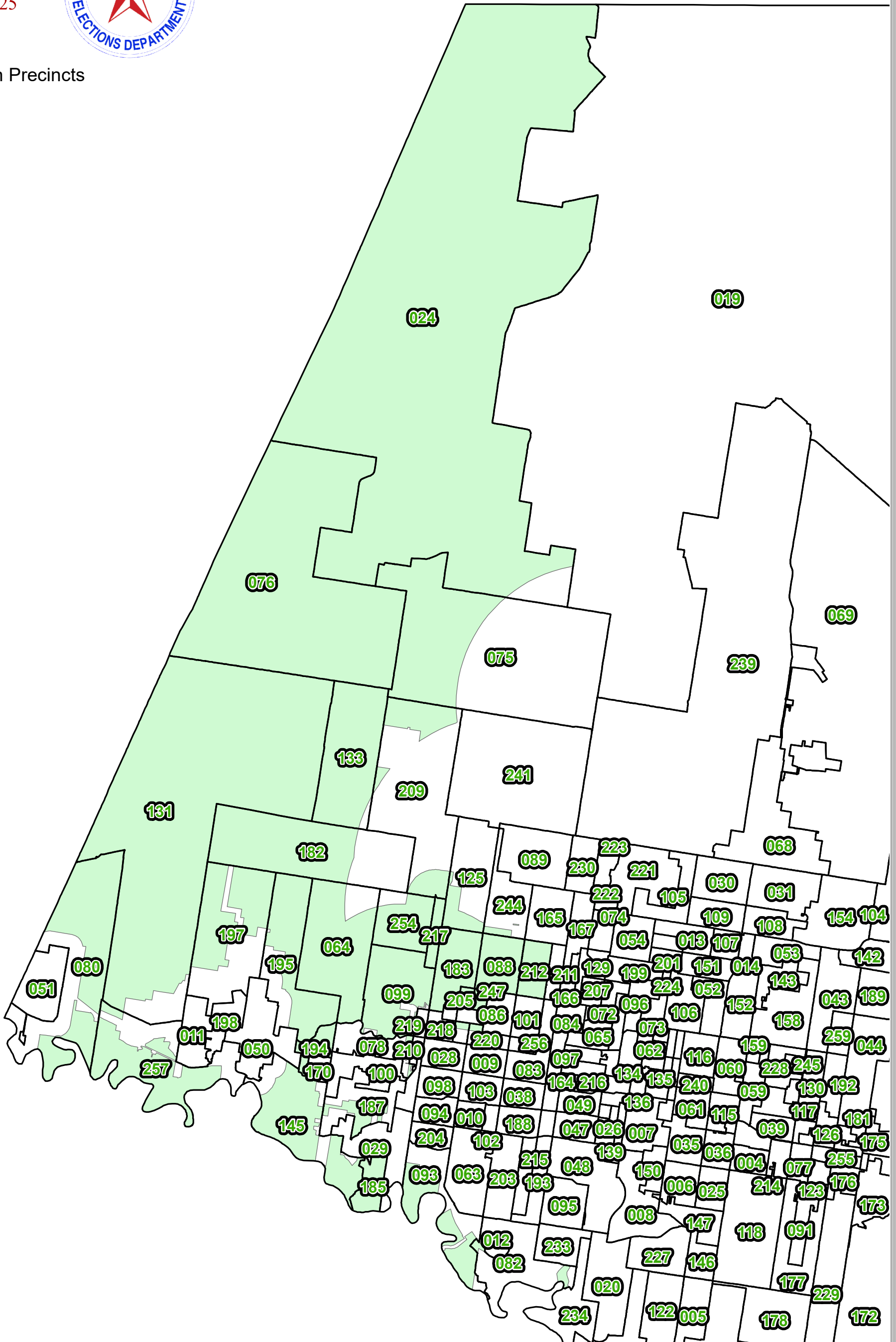
#### **HIDALGO COUNTY PRECINCT No. 3**
