CANVASSING RETURNS AND DECLARING RESULTS OF THE MAY 3, 2025 ELECTION ON THE PROPOSITION OF CONFIRMATION OF THE CREATION OF HIDALGO COUNTY EMERGENCY SERVICES DISTRICT NO. 6 AND THE LEVY BY SAID DISTRICT OF A TAX NOT TO EXCEED TEN (10) CENTS PER ONE HUNDRED DOLLAR (\$100) VALUATION AS ALLOWED BY SECTION 48-E, ARTICLE III, TEXAS CONSTITUTION.

_____ thereupon announced that the Motion had duly and lawfully carried and that the Order had been duly and lawfully adopted.

The Order thus adopted reads as follows:

ORDER CANVASSING RETURNS AND DECLARING RESULTS OF THE MAY 3, 2025 ELECTION ON THE PROPOSITION OF CONFIRMATION OF THE CREATION OF HIDALGO COUNTY EMERGENCY SERVICES DISTRICT NO. 6 AND THE LEVY BY SAID DISTRICT OF A TAX NOT TO EXCEED TEN (10) CENTS PER ONE HUNDRED DOLLAR (\$100) VALUATION AS ALLOWED BY SECTION 48-E, ARTICLE III, TEXAS CONSTITUTION.

WHEREAS, at an election held on the 3rd day of May, 2025, there was submitted to the qualified voters the question of whether that territory should be formed into an emergency services district under state law; and

WHEREAS, at the election, **102** votes were cast in favor of the formation of Hidalgo County Emergency Services District No. 6, and **21** votes were cast against the formation of Hidalgo County Emergency Services District No. 6, as described in the Canvassing Report, attached as Exhibit "B"; and

WHEREAS, the formation of Hidalgo County Emergency Services District No. 6 **did** receive the **affirmative** vote of the majority votes cast at the election as provided by law,

Now, therefore, the Commissioners Court of Hidalgo County, State of Texas, finds and orders that the territory described in the Election Order, attached as Exhibit "A," has been duly and legally formed into an emergency services district under the name of Hidalgo County Emergency Services District No. 6, under Article III, Section 48-e of the Texas Constitution as proposed by S.J.R. No. 27, Acts of the 70th Legislature, Regular Session, 1987, and adopted by the voters at an election held May 3, 2025, and has the powers vested by law in the District for providing Fire Suppression and Rescue Services.

THEREFORE, BE IT ORDERED, ADJUGED AND DECREED BY THE COMMISSIONERS COURT OF HIDALGO COUNTY, TEXAS as follows:

Section 1: The matters and facts recited in the preamble of this Order are found and determined to be true and correct; and

Section 2: The tract described in Exhibit "A" has been duly and legally formed into an emergency services district under the name of Hidalgo County Emergency Services District No. 6, under Article III, Section 48-e of the Texas Constitution, as proposed by S.J.R. No. 27, Acts of the 70th Legislature, Regular Session, 1987, and adopted by the voters at an election held May 3, 2025, and has the powers vested by law in the District for providing Fire Suppression and Rescue Services.
