THIS **SUPPLEMENTAL AGREEMENT** is made pursuant to the terms and conditions of Article 8 of the Agreement made by and between **HIDALGO COUNTY**, acting herein by and through the **Commissioner’s Court**, hereinafter called the “**Owner**”, and Halff Associates, Inc., hereinafter called the “**Engineer**”.

**WITNESSETH**

**WHEREAS**, the **Owner** and the **Engineer** executed the **Agreement No. C-22-0212-07-12** on the day of July 12th, 2022 concerning Professional Engineering Services for the “**El Paraiso Health Clinic Improvements Project & El Paraiso Community Resource Center**”;

**WHEREAS**, on the 12th day of July 2022, **Owner** authorized a Project Specific Work Authorization for **ARPA-22-123-075] - Hidalgo County Precinct 3 El Paraiso Community Resource Center & [ARPA-21-340-019] - El Paraiso Health Clinic Improvement Project** (hereinafter referred to as the “**Project**”); and

**WHEREAS**, it has become necessary to amend the Agreement to extend services and allow time to complete the project.

**NOW, THEREFORE**, in consideration of the mutual covenants provided below, the **Owner** and the **Engineer** agree that said Agreement is amended as follows:

- I. Article 6 of the **Agreement**, Term, is revised to extend the termination date of **May 31<sup>st</sup>, 2025** to **August 31<sup>st</sup>, 2025**.
- II. **All other provisions are unchanged and remain in full force and effect.**

**IN WITNESS WHEREOF**, the Engineer and the Owner have caused this Supplemental Agreement to the Agreement for Professional Services to be executed as of the 10th day of June 2025.
