- seminar is live and in person and not available virtually

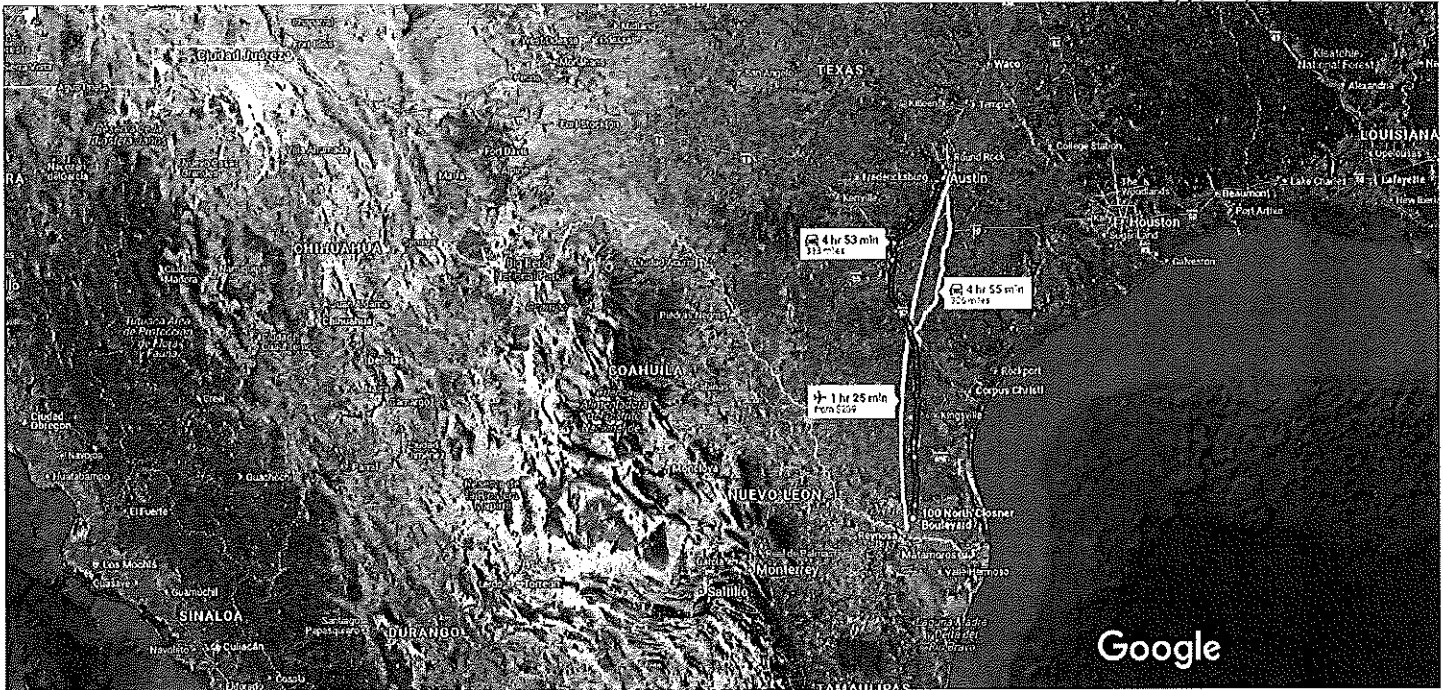
- there is no vehicle that can accommodate all employees
