RE: Sole Source Declaration for Neuralog, LP, "**Purchase of NeuraScanner Turbo**"

The Hidalgo County Elections Department seeks to procure the Purchase of NeuraScanner from Neuralog, LP.

Neuralog, LP, is the sole developer, provider and licensor of the NeuraView branded software as well as all Neuralog hardware and software products. As the only entity with access to the NeuraView Software source code, Neuralog is the only entity, which may accurately diagnose software errors, and defects, issue corrections and fully integrated enhancements, and warrant performance of the NeuraView Software and NeuraScanner Turbo. Neuralog, LP also provides professional services that are specialized in nature and focused on configuration and technical support for the proprietary software technology. These services frequently requires access to Neuralog, LP proprietary information and are not available through or resold by any third parties.

In Accordance with the Texas Local Government Code Chapter 262.024 (a)(7)(A),
(a) A contract for the purchase of any of the following items is exempt from the requirement established by section 262.023 if the commissioners court by order grants the exemption:
(7) Any item that can be obtained from only one source, including:
(A) Items for which competition is precluded because of the existence of patents, copyrights, secret processes, or monopolies.

Therefore, for the reason stated herein, we humbly request that the Hidalgo County Commissioners' Court declare a Sole Source Vendor, for the purpose of procuring the purchase with Neuralog, LP. This sole source declaration will remain in effect through the life term of the contract, unless otherwise revoked by the Hidalgo County Commissioners Court.

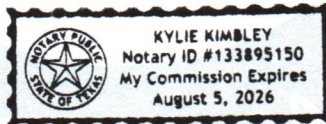
