THIS **SUPPLEMENTAL AGREEMENT** is made pursuant to the terms and conditions of Article 8 of the Agreement made by and between **HIDALGO COUNTY**, acting herein by and through the **Commissioner’s Court**, hereinafter called the “**Owner**”, and B2Z Engineering, LLC, Professional Engineers of, Mission, Texas, hereinafter called the “**Engineer**”.

**WITNESSETH**

**WHEREAS**, the **Owner** and the **Engineer** executed the **Agreement No. C-24-0150-05-28** on the day of May, 28, 2024 concerning Professional Engineering Services for Precinct No. 2;

**WHEREAS**, on the 19th day of August 2025, **Owner** authorized a Project Specific Work Authorization for [ARPA-24-340-352] - **Construction Manager at Risk for McAllen Health Center Improvement Project** (hereinafter referred to as the “**Project**”); and

**WHEREAS**, it has become necessary to amend the Agreement to extend services and allow time to finish the project.

**NOW, THEREFORE**, in consideration of the mutual covenants provided below, the **Owner** and the **Engineer** agree that said Agreement is amended as follows:

- I.       Article 3.1 of the **Agreement**, (article/paragraph title), is revised to Extend the termination date of the agreement to **May 26th, 2026**.
  
- II.       **All other provisions are unchanged and remain in full force and effect.**
