**FIRST AMENDMENT TO INTERLOCAL COOPERATION AGREEMENT BETWEEN THE COUNTY OF HIDALGO AND THE CITY OF EDINBURG, TEXAS REGARDING THE MVCPA TASK FORCE**

This **FIRST AMENDMENT** to the **INTERLOCAL COOPERATION AGREEMENT (“AMENDMENT”)** is made this \_\_\_\_\_ day of **Month, 202X** by and between **HIDALGO COUNTY, TEXAS** (the “**COUNTY**”) and **THE CITY OF EDINBURG, TEXAS** (the “**CITY**”).

**WHEREAS**, County and City entered into an Interlocal Cooperation Agreement on December 10, 2024 (the “**AGREEMENT**”) in which the Parties agreed to operate a multi-agency taskforce with the Motor Vehicle Prevention Authority of the State of Texas;

**WHEREAS**, Section No. 8 **Amendments** allows the Agreement to be amended in writing by mutual agreement of the parties.

**WHEREAS**, the parties desire to amend the Agreement as provided herein.

**NOW THEREFORE**, for and in consideration of the terms and provisions of this first Amendment to the Interlocal Agreement, both parties hereby agree to the following amendment to the Agreement.

1. The fifth **WHEREAS** paragraph is replaced with the following:

**WHEREAS**, County and City have the objective to operate a multi-agency task force funded in part by the Motor Vehicle Crime Prevention Authority of the State of Texas (MVCPA) grant, for funding in the total amount of \$827,096.00. Of which, \$223,631.00 is allocated to the City of Edinburg for the items described below;

2. Section No. 5. **Consideration** is amended as follows:

Line 1 of the chart, Edinburg PD TFOs amount is changed from \$39,648 to \$39,468.00.

3. Section No. 6 **Allocation of Funds** is replaced with the following:

The specific allocation of the City funds is set out in Exhibit “A” of this Agreement and made a part hereof for all purposes.

Except as modified herein, all terms and conditions of the Agreement, as amended, remain in full force and effect. County and City ratify and confirm the terms and provisions of the Agreement as amended.
