This **FIRST (1<sup>st</sup>) AMENDMENT** to the **Subscription Agreement** for “**CLEAR Proflex subscription and licenses**” for **Hidalgo County** in connection to original contract **C-25-0432-08-05**, dated August 5, 2025, by and between **HIDALGO COUNTY, TEXAS** (“County”) and **Thomson Reuters – West Publishing Corporation** (“Company”) is entered into between the parties effective this \_\_\_day of \_\_\_\_\_,2025.

**WHEREAS**, Company and County entered into an Agreement dated **August 5, 2025**, in which Company agreed to provide certain services for “**CLEAR Proflex subscription and licenses**” for Hidalgo County (the “Agreement”);

**WHEREAS**, both parties desire to amend the Agreement as herein provided, to increase the number of licenses from eight (8) to ten (10) and the monthly subscription payment to \$1,380.00

**WHEREAS**, both parties wish to replace the previously approved Thomson Reuters Order Form with the modified Order Form, which is attached as Attachment “A”.

**NOW, THEREFORE**, for and in consideration of the terms and provisions set forth herein, for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, County and Company hereby agree to the following amendment to the Agreement:

1. The subscription agreement shall be replaced with Attachment “A”.

Except as modified herein, all terms and conditions of the Contract, as amended, remain in full force and effect and Company and County ratify and confirm the terms, and provisions of the Contract as amended.
