settlement of such lien or liens and a proper release thereof shall be obtained.

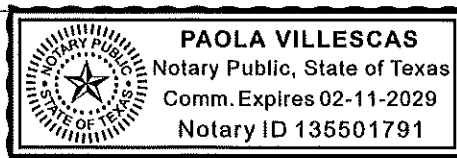
