registered account with the Rural Law Enforcement Salary Assistance Grant Program (S.B. 22), you will use the same log-in information.

Eligibility

Sheriffs are only eligible to apply for the grant if the sheriff has entered into an immigration law enforcement agreement. Details about the program can be found on our [website](#).
