**FIRST AMENDMENT TO SERVICE CONTRACT
C-25-0334-09-02**

This **FIRST (1st) AMENDMENT** to the service contract for “**Courier Services**” for **Hidalgo County** in connection to original contract **C-25-0334-09-02**, dated September 2, 2025, by and between **HIDALGO COUNTY, TEXAS** (“County”) and **Amigos Library Services** (“Company”) is entered into between the parties effective this **31st** day of **March, 2026**.

WHEREAS, Company and County entered into a Contract dated **September 2, 2025**, in which Company agreed to provide certain services for the purpose of “**Courier Services**” for **Hidalgo County** (the “Contract”);

WHEREAS, the parties now desire to amend the Contract to include an additional building in “Quote” of the initial contract;

WHEREAS, parties wish to compile all service locations to date, including the additional building added by this Amendment, into one attachment, which is attached as “Quote”

NOW, THEREFORE, for and in consideration of the terms and provisions set forth herein, for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, County and Company hereby agree to the following amendment to the Contract:

1. The site list portion of the initial contract is replaced by the updated site list.

Except as modified herein, all terms and conditions of the Contract, as amended, remain in full force and effect and Company and County ratify and confirm the terms, and provisions of the Contract as amended.
