NARRATIVE

On Tuesday, March 10, 2026 at approximately 7:30 pm, I Deputy Constable David Salinas #422 was notified via cell phone by Hidalgo County Constables Precinct 4 Deputy Chief Horaldo Sanchez #402 of the surveillance camera placed on Tex-Mex and Dillon road had been exposed and on the side of the road. I Deputy David Salinas #422 proceeded to location. Upon arrival to Tex-Mex and Dillon I observed the following:

- all equipment was removed from the tires from where it was placed.
- observed the surveillance camera missing from the area.
- observed the solar power panel exposed and having the antenna broken.
- observed the gray power box exposed next to the solar power panel.
- observed the antenna broken from the power box.
- recovered all equipment and took it with me for safekeeping.
- checked the area, but did not find the camera nor suspect.
- a case number was requested and a report filed.
- pending follow up investigation for Theft and Criminal Mischief.
- Surveillance camera is used to catch people throwing trash or tires in this general area due to high volume of illegal dumping.

SUPPLEMENTAL NARRATIVE

On Wednesday, March 11, 2026, at approximately 9:53 am, Deputy David Salinas #422 proceeded to the address of Tex-Mex Rd. and Dillon Rd. in the city of Edinburg, TX 78542 to search for the missing surveillance camera.

- searched the area and did not find the surveillance camera.
- drove to the address of 422 Buddy Lane in Donna, Tx 78537, from the Dodge Durango's registered address.
- made contact with a female (later identified as Jassmin Reyna).
- asked the female who drives the Dodge Durango and she advised it's hers in Spanish.
- asked her if she knew why we were there and she stated 'yes, a little bit in'.
- asked her for the camera and she advised in Spanish "it's in the canal bank".
- didn't ask her anything else and she stated in Spanish "that she needed to go to the restroom, and she saw the camera and she got embarrassed".
- she continued to state in Spanish "saw the camera and she threw it in the canal; she advised that she did wrong.
- she stated that she would take us to where the camera is at and that she would go into the canal to get it.
- advised her to follow us to where the camera is and then she would follow us to the office.
- she asked if she was going to get arrested and she was advised there is a process.
- the female went inside to change and was advised to bring her driver's license with her.
- I walked to the vehicle where I recorded it with my body camera.
- shortly after that, the female walked back outside where she was identified through her Texas Driver's license#48374917 as Jassmine Reyna, D.O.B. 05/20/1998
- Hidalgo County Precinct 4 Constable's office Deputy Chief Sanchez assisted as a backup officer.
- we followed the defendant from her home to the canal bank located on Sunflower St., south of Tex-Mex rd. Edinburg, Tx 78542.
- at approximately 10:07 am, we arrived at location on sunflower St. south of Tex-Mex Road.
- the defendant pointed to where she threw the camera.
- she advised she would go inside the canal bank to get the camera.
- I advised her that was not necessary.
- I did not ask the defendant anything and she advised she is so embarrassed in Spanish and she had to go to the restroom.
- I took a photograph of the area of the canal bank.
- the defendant followed us to the Hidalgo County Precinct 4 Constable's office where she was


