As discussed, we understand that two cameras will be relocated and two will be added. Therefore, as discussed, we recommend modifying the agreement by replacing the existing No. 1 with the following:

1. Relocation of previously approved cameras - the locations will be moved to the following places:

- P#012: [38483 FM 1017, Linn, TX](#) - 26.651024,-98.355900
- P#013: [38156 Mile 7 Rd, Penitas, TX](#) - 26.333114,-98.430751

2. Approval of installation of two additional cameras located at the following places:
