FIRST AMENDMENT TO 2024 -YR 37 EMERGENCY SOLUTIONS GRANTS PROGRAM (ESG) SUBRECIPIENT AGREEMENT

This First Amendment to the 2024 – YR 37 Emergency Solutions Grants Program (ESG) Subrecipient Agreement is made as of the 26th day of May, 2026 by and between the **COUNTY OF HIDALGO, TEXAS**, Urban County Program, a grant recipient of the United States Department of Housing and Urban Development (“HUD”), and a political subdivision of the State of Texas, hereinafter referred to as “**ENTITY**”, and **WOMEN TOGETHER FOUNDATION INC.**, a neighborhood based not-for-profit organization, hereinafter referred to as “**SUBRECIPIENT**”.

WHEREAS, On or about June 10, 2025, Entity and Subrecipient entered into a 2024 – YR 37 Emergency Solutions Grants Program (ESG) Subrecipient Agreement (the “Agreement”), wherein Parties contracted so Subrecipient may carry out eligible activities as described therein;

WHEREAS, On or about March 23, 2026, Subrecipient was advised that the amount of grant funds originally awarded would be increased by a specified amount in unobligated funds, and as such, it has become necessary and the parties desire to amend the Agreement to reflect the incorporation of the additional awarded amount into the Agreement.

WHEREAS, Section XIX, titled “Entire Agreement” allows for the Agreement to be modified or amended “only by an agreement in writing executed by ENTITY and SUBRECIPIENT, and not otherwise”;

NOW, THEREFORE, for and in consideration of the terms and provisions set forth herein, for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Parties hereby agree to the following amendment to the Agreement:

1. Modify, revise or replace the first paragraph of Section II of the Agreement to reflect the updated award amount, as follows:

SUBRECIPIENT agrees to perform services as outlined in **Exhibit A: Statement of Work**, of this Agreement for and in consideration of ESG funding in the amount of \$ **199,125.00** enumerated in **Exhibit B-1 (the “Grant Budget”)** and **Exhibit B-2 (the “Payment Schedule”)**.

2. Replace **Exhibit B-1: Grant Budget** to the Agreement with the updated **Exhibit B-1: Grant Budget** attached hereto as *Attachment A* which reflects modifications of the amounts allocated to types of expenditures due to the increase in awarded funds.

3. Replace **Exhibit B-2: Payment Schedule** to the Agreement with the updated **Exhibit B-2: Payment Schedule** attached hereto as *Attachment B* which reflects modifications of the amounts paid in applicable months due to the increase in awarded funds.

Except as modified herein, all terms and conditions of the Agreement, as amended, remain in full force and effect and ENTITY and SUBRECIPIENT ratify and confirm the terms, and provisions of the Agreement as amended.
