**FIRST AMENDMENT TO INTERLOCAL COOPERATION AGREEMENT &  
BUSINESS ASSOCIATE AGREEMENT BETWEEN THE COUNTY OF HIDALGO  
AND DONNA INDEPENDENT SCHOOL DISTRICT**

This **FIRST AMENDMENT** to the **INTERLOCAL COOPERATION AGREEMENT and INCORPORATED BUSINESS ASSOCIATE AGREEMENT (“AMENDMENT”)** is made this 9<sup>th</sup> day of **June, 2026** by and between **HIDALGO COUNTY, TEXAS** (the “**COUNTY**”) and **DONNA INDEPENDENT SCHOOL DISTRICT** (the “**DISTRICT**”).

**WHEREAS**, County and District entered into an Interlocal Cooperation Agreement and Incorporated Business Associate Agreement on June 15, 2021 (the “**AGREEMENT**”) in which the Parties agreed to assist one another to improve local bioterrorism preparedness and response to outbreaks on infections disease and other public health threats and emergencies for the good of the health, welfare and safety of their constituents and the general public;

**WHEREAS**, Section No. 12 **Term** allows C-20-561K-06-15 to renew for a period of five (5) years by written amendment.

**WHEREAS**, the parties desire to amend the Agreement to exercise its first and final option for a five (5) year renewal of the agreement.

**NOW THEREFORE**, for and in consideration of the terms and provisions of this first Amendment to the Interlocal Agreement, both parties hereby agree to the following amendment to the Agreement.

1. The Agreement shall be extended for a period of five (5) years, to run from June 15, 2026 to June 14, 2031, as permitted under section no. 12 of the Agreement.

Except as modified herein, all terms and conditions of the Agreement, as amended, remain in full force and effect and District and County ratify and confirm the terms, and provisions of the Agreement as amended.
