**1st AMENDMENT TO SERVICE CONTRACT
C-26-0102-03-31**

This **AMENDMENT** to the service contract for “**Inmate E-Commerce Services**” for Hidalgo County in connection to original contract **C-26-0102-03-31** dated **March 31, 2026**, by and between **HIDALGO COUNTY, TEXAS** (“County”) and **JJ-AD Enterprises, LLC dba Hidalgo Snacks** (“Company”) is entered into between the parties effective **March 31, 2026**.

WHEREAS, Company and County entered into a Contract dated **March 31, 2026**, in which Company agreed to provide certain services for the purpose of “**Inmate E-Commerce Services**” for Hidalgo County (the “Contract”);

WHEREAS, Section j, titled “Entire Agreement” allows for **C-26-0102-03-31** to be modified or amended “only by an agreement in writing executed by County and Company, and not otherwise”;

WHEREAS, On July 13, 2026, JJ-AD Enterprises, LLC dba Hidalgo Snacks provided a notice to HCSO of its request to decrease their commission rate for care packages from **30%** to **20%**;

WHEREAS, HCSO approves the request to decrease their commission rate in order to help keep reasonable pricing for our inmate families;

NOW, THEREFORE, for and in consideration of the terms and provisions set forth herein, for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, County and Company hereby agree to the following amendment to the Contract:

1. As listed on Exhibit B - Company’s Response, letter “A” will be replaced with the following:

**A. Commission Fee (monthly payment) based on monthly sales for care packages
20%**

Except as modified herein, all terms and conditions of the Contract, as amended, remain in full force and effect and Company and County ratify and confirm the terms, and provisions of the Contract as amended.
