**AMENDMENT NO. 4
TO MEMORANDUM OF AGREEMENT BETWEEN
TEXAS A&M UNIVERSITY HEALTH SCIENCE CENTER (TEXAS A&M HEALTH)
AND HIDALGO COUNTY**

This FOURTH AMENDMENT to the Memorandum of Agreement is made on this **18th day of August, 2026**, by and between the COUNTY OF HIDALGO, TEXAS (hereinafter referred to as “County”), and Texas A&M University Health Science Center (hereinafter referred to as “Texas A&M Health”), collectively referred to as “Parties”.

WITNESSETH:

WHEREAS, on August 09, 2022, Texas A&M Health and County of Hidalgo, entered into a Memorandum of Agreement;

WHEREAS, the purpose of this Agreement is to establish a cooperative agreement to provide medication assistance services to the uninsured residents within Hidalgo County, with a special emphasis on medically underserved and rural communities.

WHEREAS, Section 5 “TERM OF AGREEMENT” of the Memorandum of Agreement allows C-22-0623-08-09 upon mutual agreement of Parties, to amend the Agreement to extend the term for up to four (4) additional one (1) year terms.

WHEREAS, on May 30, 2023, Parties exercised the first (1st) of the four (4) extensions to run from September 1, 2023 to August 31, 2024.

WHEREAS, on August 20, 2024, Parties amended the agreement to exercise the second (2nd) of the four (4) extensions to run from September 1, 2024 to August 31, 2025 and included additional service location.

WHEREAS, on September 02, 2025, Parties amended the agreement to exercise the third (3rd) of the four (4) extensions to run from September 1, 2025 to August 31, 2026.

WHEREAS, the Parties desire to amend the Agreement to exercise its fourth (4th) option for annual renewal of the agreement.

NOW THEREFORE, for and in consideration of the terms and provisions of this Amendment to the Memorandum of Agreement and for good and valuable consideration the receipt and sufficiency of which are hereby acknowledged, Texas A&M Health and County hereby mutually agree to amend the Agreement as follows:

1. The Agreement shall be extended for a period of one (1) additional year, to run from September 1, 2026 to August 31, 2027, as permitted under section 5 of the Agreement.

All other information on Section 5 remains the same.

Except as modified herein, all terms and condition of the Agreement, as amended, remain in full force and effect, and the Parties ratify and confirm the terms, and provisions of the Agreement as amended.
