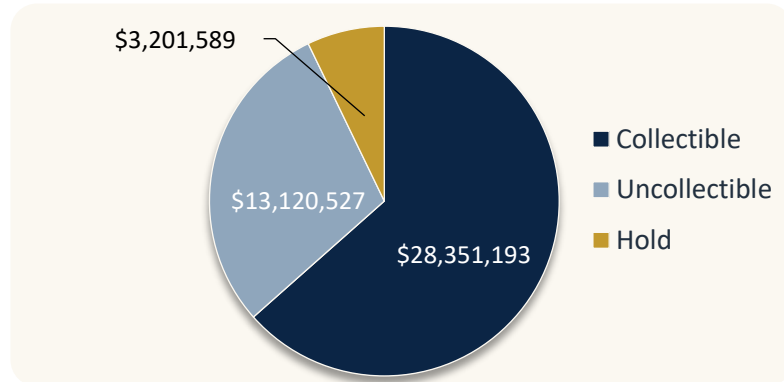
Delinquent Tax Levy



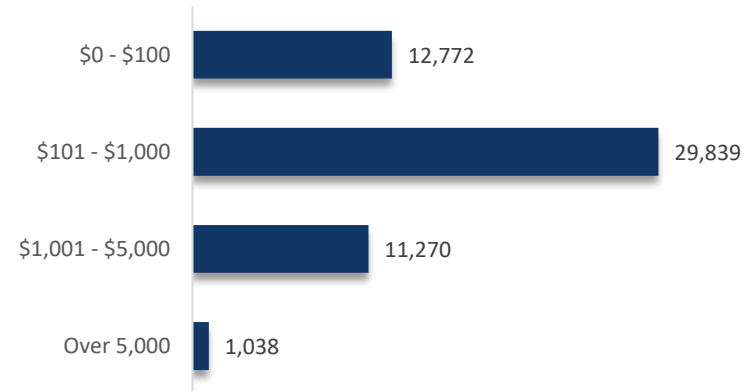

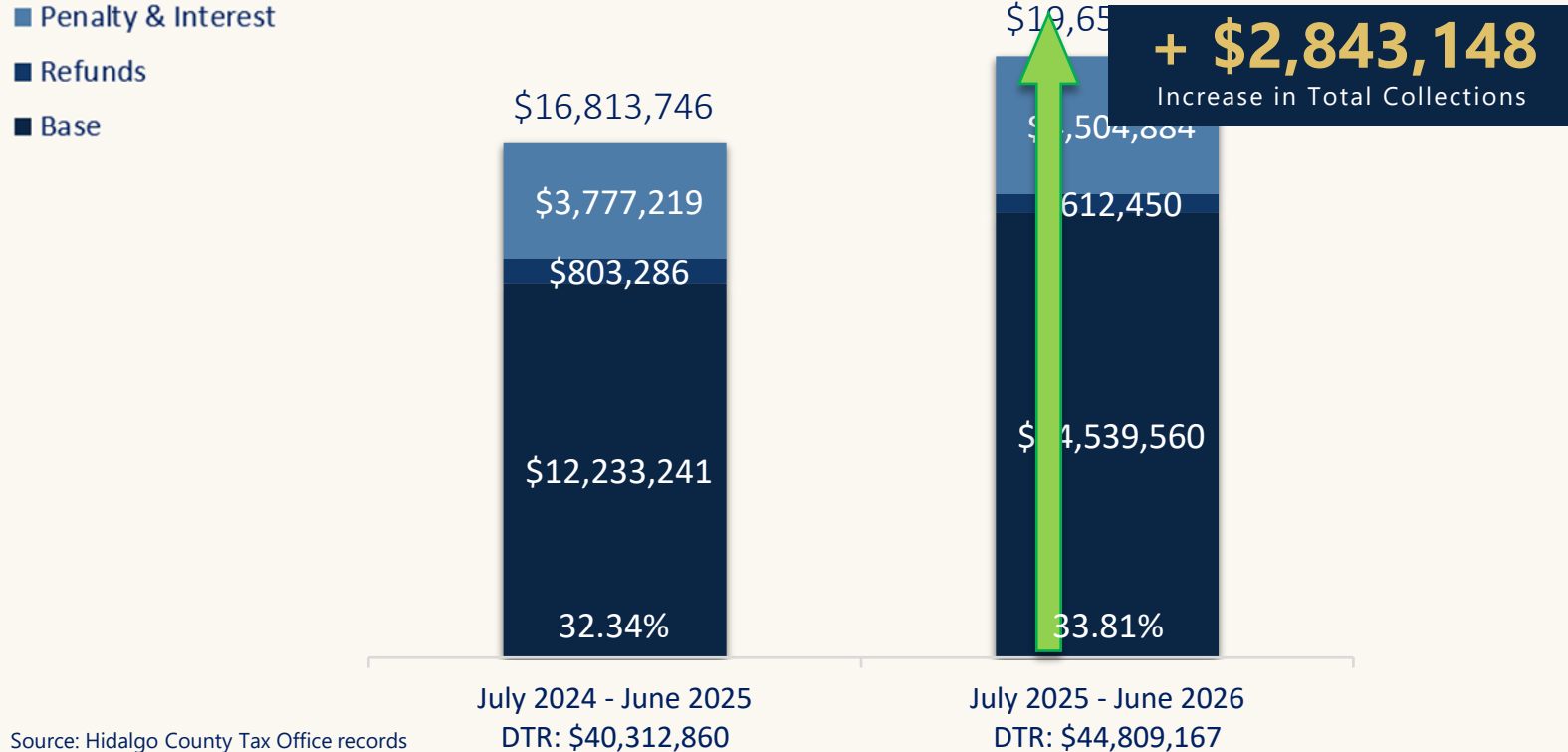
