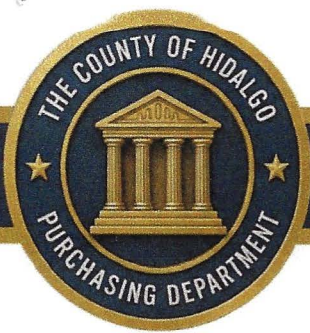




CERTIFICATE OF CONSTRUCTION COMPLETION

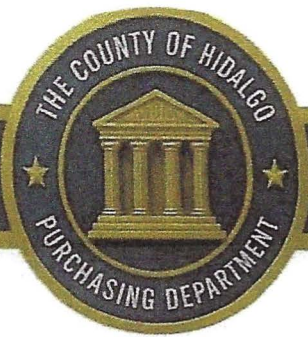

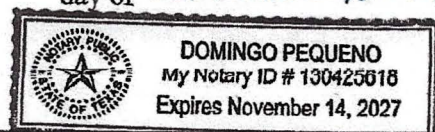

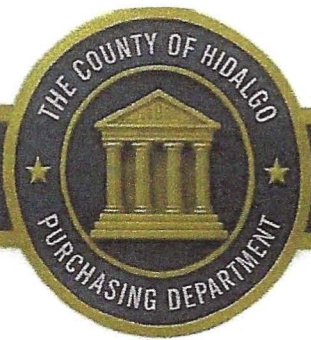
