**ORDER OF THE HIDALGO COUNTY COMMISSIONERS COURT
DESIGNATING AREA FOR SALE OF REAL PROPERTY UNDER A POWER
OF SALE CONFERRED BY DEED OF TRUST OR OTHER CONTRACT LIEN**

WHEREAS, Section 51.0002(h) of the Texas Property Code provides the Commissioners Court may designate an area other than an area at the courthouse as provided in Section 51.002 (a) of the Texas Property Code where sales of real property pursuant to a deed of trust or other contract lien, may take place; and

WHEREAS, the Hidalgo County Commissioners Court, after reviewing the locations available, has determined that it is more suitable for the public and the operation efficiency of the Courthouse that sales of real property should be held at the south side under the covered space of the County Clerk Records Management Facility (previously known as Robert’s Chevrolet building) with a physical address of 317 North Closner, Edinburg, Texas;

NOW THEREFORE, IT IS HEREBY ORDERED BY THE COMMISSIONERS COURT OF HIDALGO COUNTY, TEXAS that the south side under the covered space of the County Clerk Records Management Facility (previously known as Robert’s Chevrolet building) with a physical address of 317 North Closner, Edinburg, Texas is hereby designated as the area where sales of real property are to take place pursuant to a deed of trust or other contract lien.


BE IT FURTHER ORDERED, this Order shall be recorded by the County Clerk of Hidalgo County in the real property records of Hidalgo County, Texas.
