**AMENDEDMENT TO PROFESSIONAL ENGINEERING AGREEMENT BETWEEN  
HIDALGO COUNTY, TEXAS AND  
CHANIN ENGINEERING LLC  
C-14-056-02-11**

This **AMENDMENT AGREEMENT BETWEEN THE COUNTY OF HIDALGO, TEXAS** (Owner) and **CHANIN ENGINEERING LLC.**, (Company), effective the 3<sup>rd</sup> day of **JUNE 2014**, is made between the parties, as follows:

**WHEREAS**, on February 11, 2014, Hidalgo County (the "Owner") entered into a Professional Engineering Agreement (the "Agreement") with Chanin Engineering LLC. (the "Engineer"), in which the Engineer would provide "Professional Engineering Services" for the project specific "Delta Lake Pavilion-Hidalgo County Precinct One", as described in the Agreement;

**WHEREAS**, the parties desire to amend the Contract as hereinafter provided.

**NOW THEREFORE**, for and in consideration of this mutually agreed Amendment to the Agreement, Owner and Engineer hereby agree to the following Amendment to the Agreement:

1.     5.1 Services. The first sentence of Article 5.1 titled Services is deleted in its entirety and the following is inserted in lieu thereof:

For and in consideration of the *Services* to be rendered by the *Engineer*, as identified in Article 2 and more particularly identified in EXHIBIT "B", attached hereto, the amount payable by the Owner to the Engineer for Services will be the amount described in EXHIBIT "C" attached hereto and incorporated herein at this point and it is subject to adjustment in accordance with the terms and provisions of Article 6.1 herein.

2.     The fifth sentence of Article 6.1 shall be deleted in its entirety.
3.     Except as modified herein, all terms and conditions of the Agreement, as amended, remain in full force and effect. Company and Owner ratify and confirm the terms and provisions of the Agreement as amended.

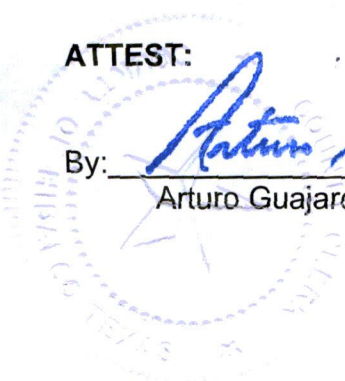
