



**Interlocal Contract**  
**Between Region III Education Service Center and**  
**Hidalgo County**

Pursuant to Texas Government Code, Chapter 791, Interlocal Cooperation Act, and Texas Local Government Code, Chapter 271, Subchapter F. Cooperative Purchasing Program, the Interlocal Contract (ILC) is made and entered into between Region III Education Service Center, 1905 Leary Lane, Victoria, Texas 77901, and Hidalgo County (Participating Agency), located at 2812 S. Bus. Hwy 281 Edinburg, Texas 78539 for the purpose of providing/participating in the cooperative purchasing services of Purchasing Cooperative of America.

**Region III Education Service Center will:**

- Administer the **Purchasing Cooperative of America** cooperative purchasing program.
- Provide legally awarded contracts.
- Provide service and support to PCA members.
- Provide up to date information concerning contracting opportunities with PCA vendors.

**Participating Agency, as a member of Purchasing Cooperative of America, will:**

- Designate a contact person and update the contact information as necessary.
- Provide an authorized signature on the ILC.
- Work with vendors according to the PCA contract.
- Issue Purchase Orders stating "Purchasing Cooperative of America" and the Contract Number.

This contract is effective the date of the final signature and will remain in effect until and unless one (1) of the parties terminates the agreement in writing with thirty (30) days notice.


