

**INTERLOCAL AGREEMENT FOR
PAVING GREGORIO GARZA STREET,
LOS EBANOS, TEXAS**

This Interlocal Agreement to pave the damaged portion of Gregorio Garza Street in Los Ebanos, Texas (“Agreement”) is hereby entered into by and between Hidalgo County (the “County”), and the Agua Special Utility District (the “District”), collectively (the “Parties”).

**ARTICLE I.
RECITALS**

WHEREAS, the District has placed utility lines in the Right of Way on Gregorio Garza Street in Los Ebanos, Texas; and

WHEREAS, portions of Gregorio Garza Street in Los Ebanos, Texas where Agua lines exist are in need of repair due to heavy use and rainfall; and

WHEREAS, the parties agree that the City of Los Ebanos and its citizens, the District and the County would benefit from the re-paving with asphalt of Gregorio Garza Street; and

WHEREAS, the Interlocal Cooperation Act (Chapter 791, Texas Government Code) (the “Act”) empowers the Parties to contract with each other in the performance of governmental functions and services, including parks and recreation; and

WHEREAS, the County and the District are “local governments” within the meaning of the Act;

WHEREAS, the County and the District each itself has the authority under Texas law to pave roads within their jurisdiction; and

WHEREAS, The District desires to contribute funds of the purchase of the materials and the County desires to contribute the labor, equipment, and machinery to pave the affected portion of Gregorio Garza Street;

NOW THEREFORE, in consideration of the mutual covenants and agreements contained herein, as well as other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, both the County and the District agree as follows:

**ARTICLE II.
RECITALS**

The recitals contained herein are found to be true and correct and are hereby incorporated into this Agreement in their entirety.

**ARTICLE III.
AGREEMENT AND OBLIGATIONS OF THE PARTIES'
IN PAVING OF GREGORIO GARZA STREET**

1. The County agrees to repave the damaged portion of Gregorio Garza Street in Los Ebanos, Texas, with asphalt, including the provision of all necessary labor, equipment and machinery.


2. The District agrees to contribute funds to the county in the amount described on the attached Hidalgo County Project Worksheet dated December 8, 2014 to purchase the identified materials necessary for the re-paving in asphalt of the affected portion of Gregorio Garza Street in Los Ebanos, Texas.

**ARTICLE IV.
TERMINATION**

Term. This Agreement will terminate on the earlier of: (1) the paving of Gregorio Garza Street, pursuant to the terms set forth in this Agreement; or (2) one year from the date of this Agreement.
