**SUPPLEMENTAL AGREEMENT NO. 2
TO WORK AUTHORIZATION NO. 1
Contract No. C-12-314-01-29**

THIS SUPPLEMENTAL AGREEMENT is made pursuant to the terms and conditions of the Agreement made by and between the HIDALGO COUNTY, acting herein by and through COMMISSIONER'S COURT, hereinafter called the "OWNER," and, R. Gutierrez Engineering Corporation, professional engineers of Pharr, Texas, hereinafter called "ENGINEER".

WHEREAS, OWNER and ENGINEER executed Work Authorization No. 1 to Contract No. C-12-314-01-29, on the 9th day of April 2013, to provide professional engineering and surveying services for Rancho Blanco Road improvement project from Alamo Road to Tower Road, and;

WHEREAS, in Work Authorization No. 1, the estimated cost for services under the Work Authorization was \$20,280.00, and;

WHEREAS, in Supplemental Agreement No. 1 to Work Authorization No. 1, the estimated cost for services under the Work Authorization was revised to \$31,283.00, and it has now become necessary to further revise the estimated cost for services;

NOW THEREFORE, for and in consideration of the terms and provisions set forth herein and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, OWNER and ENGINEER agree to the following amendment to Work Authorization No. 1 as follows:

1. The estimated cost for services under this Work Authorization is now an actual cost for services of \$32,327.68.
2. Except as amended by this Supplemental Agreement, the remaining provisions of the Agreement are unchanged and shall remain in full force and effect.

IN WITNESS WHEREOF, the ENGINEER and OWNER have caused this Supplemental Agreement to Work Authorization No. 1, for Professional Engineering Services to be executed as of the 19th day of May 2015.
