**AMENDMENT TO INTERLOCAL COOPERATION AGREEMENT
BETWEEN HIDALGO COUNTY DRAINAGE DISTRICT NO. 1
AND HIDALGO COUNTY**

This AMENDMENT to the INTERLOCAL AGREEMENT is made this 23rd day of June, 2015 by and between HIDALGO COUNTY DRAINAGE DISTRICT NO. 1 (the "District") and HIDALGO COUNTY (the "County").

WHEREAS, District and County entered into an Inter-local Agreement dated January 17, 2006 (the "Agreement") whereby the County agreed to provide certain administrative and support services to District (the "Work");

WHEREAS, upon request by the District, the County may provide additional services upon such terms and conditions as may be mutually agreed to between District and County;

WHEREAS, the District has determined the need for District Employee Payroll Service and Related Payroll Services, and herein request these additional services be provided;

NOW THEREFORE, for and in consideration of the terms and provisions set forth herein, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and attached herein as Exhibit "A", District and County hereby agree to the following amendment to the Agreement.


1. Subparagraph (l) shall be added to numbered Paragraph 1 of the Agreement to read as follows:

"l. The County shall provide the District Payroll Service for District Employees, and related payroll services by and through the Hidalgo County Treasurer's Office."

2. Except as modified herein, all terms and conditions of the Contract, as amended, remain in full force and effect and District and County ratify and confirm the terms and provisions of the Agreement as amended.




