WHEREAS, the parties desire to amend the Work Authorization Attachment Exhibit "D" as hereinafter provided.



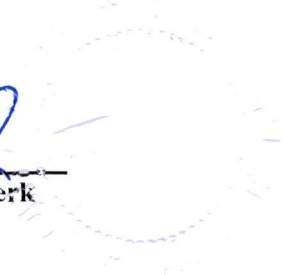
