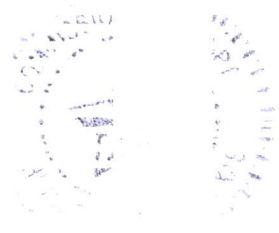

PROJECT**

In accordance with Texas Government Code §791.014, Hidalgo County, Texas, acting by and through Precinct 2 executed a certain Interlocal Cooperation Agreement with the City of San Juan, Texas whereby Hidalgo County, Texas agreed to provide City of San Juan, Texas with labor, equipment and materials at Hidalgo County's cost. The City of San Juan, Texas has requested the County to provide labor, equipment and materials for the Reclamation and Overlay of Cesar Chavez Road from Business 83 to Carroll Street and from the North Side of IH 2 along Cesar Chavez Road to FM 495, a Distance of 5560 Linear Feet which lies within the corporate limits of the City of San Juan.

By vote on Feb. 16, 2016, the Hidalgo County Commissioners Court has approved the project identified above.
