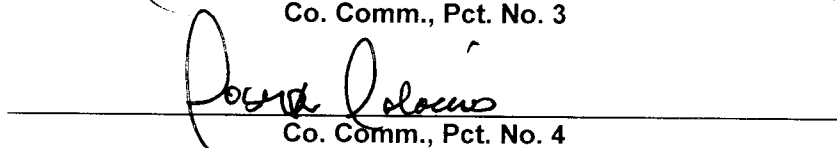

Dear Judge and Commissioners:

In accordance with Local Government Code Section 111.093, a requisition issued or a contract for work, labor, services, or materials and supplies is not binding until the county auditor certifies that the budget contains an ample provision for the obligation and that funds are or will be available to pay the obligation when due. Recommend that agreements/contracts be revised to include the County Auditor's signature as certification of available funds.

Consent Agenda Item 10.D. (AI-54120) – Purchasing Department

Recommend No Action: The Certificate of Interested Parties (FORM 1295) was not attached. Therefore, we could not determine compliance with Section 2252.908 of the Government Code.

Regular Agenda Item 7.C. (AI-54111) – Executive Office

Recommend No Action: Pursuant to Local Government Code § 262.011 (d), "the county purchasing agent shall purchase all supplies, materials, and equipment required or used, and contract for all repairs to property used, by the county or a subdivision, officer, or employee of the county, except purchases and contracts required by law to be made on competitive bid. A person other than the county purchasing agent may not make the purchase of the supplies, materials, or equipment or make the contract for repairs." A purchase order was not obtained from the Purchasing Department prior to the procurement of tablecloths; therefore, the Auditor's Office will not be able to pay for the tablecloths.

Regular Agenda Item 11.B. (AI-54148) – Elections Administration

Recommend No Action: A fiscal note was not attached to identify the fiscal impact of and proposed funding for the proposed action.

Regular Agenda Item 14.B. (AI-54108) – Justice Court Technology Fund

Recommend No Action: The purpose for the appropriation includes the purchase of equipment for the Constables. The Justice Court Technology Fund established under Code of Criminal Procedure article 102.0173 may be used only for technological enhancements for the justice courts and continuing education and training for justice court judges and clerks regarding technological enhancements.

Recommend No Action: Exhibit A-1 referenced in the agreement and legal counsel's approval of the agreement were not attached.

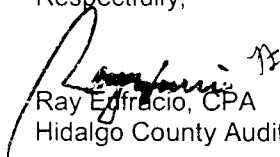
