Dear Judge and Commissioners:

**In accordance with Local Government Code Section 111.093, a requisition issued or a contract for work, labor, services, or materials and supplies is not binding until the county auditor certifies that the budget contains an ample provision for the obligation and that funds are or will be available to pay the obligation when due. Recommend that agreements/contracts be revised to include the County Auditor's signature as certification of available funds.**

Consent Agenda Item 2.X. (AI-54385) – 2016 Intradepartmental Transfer for County Clerk  
Recommend No Action: The transfer is to fund the purchase of a vehicle from the County Clerk Records Archive budget. Pursuant to Local Government Code Sec. 118.025(f), funds from the record archive account may be expended only for the preservation and restoration of the county clerk's records archive as provided by the annual plan. The purchase of a vehicle does not appear to be a permissible expense from the records archive account.

Consent Agenda Item 2.CC. (AI-54365) – 2016 Intradepartmental Transfer for County Clerk  
Recommend No Action: The transfer is to fund the purchase of a counterfeit machine from the County Clerk Records Management and Preservation Fund. Pursuant to Local Government Code Sec. 118.0216, funds from the County Clerk Records Management and Preservation Fund may be used only to provide funds for specific records management and preservation, including for automation purposes. The purchase of a counterfeit machine does not appear to be a permissible expense from the County Clerk Records Management and Preservation Fund.

Recommend No Action: There are no reports to present for this standing item.

Consent Agenda Item 10.B.3 (AI-54340) – Purchasing Department  
Recommend No Action for Premier Uniforms: The Certificate of Interested Parties (FORM 1295) was not attached. Therefore, we could not determine compliance with Section 2252.908 of the Government Code.


