





authorize an emergency expenditure as an amendment to the original budget only in a case of grave public necessity to meet an unusual and unforeseen condition that could not have been included in the original budget through the use of reasonably diligent thought and attention. It appears that this emergency appropriation does not meet the requirements of Local Government Code Sec. 111.070(b) since the event happened in May 2015 prior to the adoption of the 2016 budget. In addition, emergency expenditures were previously authorized for this even in June and September of 2015.
